Course Description: A preparatory course assisting students in searching for quality literature, critiquing literature, identifying and developing research topics, and improving the quality of academic writing. This course is a preparatory direct connection to LSTD 4953 Study In Depth.

Course Objectives: At the conclusion of this course, the student should be able to:

1. Conduct literature searches at libraries, online, and from organizational documents.
2. Critique literature on quality of the written document and the results contained in the literature.
3. Understand how interdisciplinary influences the quality of topics in the liberal studies.
4. Write quality in-depth papers focusing on interdisciplinary topics.
5. Use proper documentation and referencing in writing in-depth papers similar to the SID.
6. Understand the Study In Depth process in preparation for the final SID required in the BALS Liberal Studies Degree Program.

Assignments:

Assignment 1 –Interdisciplinary Essay (75 points). This essay should define the term “interdisciplinary” in an academic context. Then, the essay should discuss the strengths and challenges of an interdisciplinary curriculum. Describe an aspect of your topic from the point of view of a) the humanities; b) social sciences; c) natural sciences. This essay should be a minimum of 600 words double-spaced and typed using a one and a half inch top margin with the other margins set at one inch. Underline the topic/thesis sentence in the introductory paragraph. When citing references, use either the APA or MLA style as noted by The Longman Handbook.

Assignment 2 - Researching your Topic (50 points). A) identify a topic. B) List the disciplines it covers. C) Find 15 references that relate to your topic. Make notes so that you can prepare an annotated bibliography later. D) Write down the references and prepare a list. Use either APA or MLA style.

Assignment 3 – Annotated Bibliography (50 points). A) Write down the reference, using either APA or MLA style. B) How does this relate to your topic? C) What information does it provide? D) From which discipline does this paper approach your topic? E) Is the paper controversial? Does it contain opinions or information that others disagree with? What are they? F) Why do you find this paper interesting? G) Repeat for all 15 sources.

Assignment 4 – Study in Depth Outline (50 points). A) Familiarize yourself with the Study in Depth Prospectus form. B) Develop the form for your own prospectus. (sample will be provided) C) In a separate document, develop a detailed outline of your topic. D) Identify 5 places where you need to expand your research in order to be able to write from your outline.

Assignment 5 – Academic Integrity Essay and Quiz (75 points) This essay should define and expand upon the topic of plagiarism. It should be a minimum of 600 words and typed and double-spaced using a one and a half inch top margin with the other margins set at one inch. Underline the topic/thesis sentence in the introductory paragraph. When citing references, use either the APA or MLA style as noted by The Longman Handbook.

Class Format: There will be a variety of classroom techniques used for this course – lecture, discussion, group work, and individual and group presentations.

- (d) Fraud: the falsification, forgery, or misrepresentation of academic work, including the resubmission of work performed for one class for credit in another class without the informed permission of the second instructor; or the falsification, forgery or misrepresentation of other academic records or documents, including admissions materials and transcripts; or the communication of false or

misleading statements to obtain academic advantage or to avoid academic penalty;

(e) Destruction, misappropriation or unauthorized possession of University property or the property of another;

(f) Bribery or intimidation;

(g) Assisting others in any act proscribed by this Code; or

(h) Attempting to engage in such acts.
