Directions for Using Publisher Contact Form

The South Central Modern Language Association has arranged with The Scholar's Choice to manage the combined book exhibit for our annual meeting taking place November 6-8, 2008 in San Antonio, Texas. It is possible for your recently-published books to be included in their display. Please refer to the guidelines below:

- 1. Use a separate copy of this form (form on reverse; photocopy as needed) for each book you would like to have exhibited. Fill in all the appropriate information, including the name and address of each publisher. The Scholar's Choice has asked that members request only books that are appropriate, albeit in the broadest sense, to the topics of the conference. They have also asked us to be mindful of publication dates. Publishers may not be able to fill orders for older or out-of-stock books.
- 2. Send one copy of your request directly to your publisher. Send another to us at SCMLA, University of Oklahoma, 104 Fourth Street, Baker, B47, Norman, OK 73019-6410. It is suggested that you do this as early as possible, but no later than **September 12, 2008**. Late requests may not be honored either by the publisher or by The Scholar's Choice due to limited exhibit space.
- 3. Making a request to your publisher does not guarantee that your book will be exhibited. You should contact your publisher to determine whether or not your book has been reserved.
- 4. Although The Scholar's Choice works primarily with academic and scholarly presses, we have been assured of their willingness to exhibit textbooks, fiction, and/or poetry from any press that can meet their guidelines and fees.

Any members interested in having their book displayed at the upcoming SCMLA meeting should contact their publisher *as soon as possible*. Please keep in mind that the publishers pay a fee to display with The Scholar's Choice and may not have the marketing budget necessary to honor all requests, particularly for older titles. Reservations from the publishers will be accepted on a first-come, first-served basis so reserving early is highly recommended. Please note that The Scholar's Choice displays on behalf of the publishers and *ALL requests must come from them, not the author*.
