Student Nominations

Exchange Student Nominations are two times per year. Partner institutions must nominate exchange students to the Office of International Student Services by **the deadline**.

SEMESTER OF STUDY	NOMINATIONS DEADLINE
Academic Year or Fall (only)	March 15th
Calendar Year or Spring (only)	September 15th

To attend OU as an exchange student, applicants must have completed their first year and be in good academic standing. Home university coordinators must use [OU's Nomination Form](#) to nominate students each term. After nomination, students receive a confirmation email, followed by the application link and instructions.

Application Requirements

After nominations close, the Exchange Student Coordinator will email each nominated student an application link with instructions. Students must check their email regularly during this process.

Applicants must submit the following online (no hard copies required)

1) Biographical page of passport

2) Evidence of English proficiency

3) Financial support documentation

4) University transcripts (must be translated into English) and current course enrollment

5) Course preferences (requested later)

English Proficiency Requirements

Applicants whose home university does not use English as the primary language of instruction must submit valid English proficiency scores with their application—OU cannot admit students without this documentation.

Accepted tests: TOEFL (paper or iBT), IELTS, PTE, or Duolingo (DET). TOEFL ITP is not accepted.

Minimum scores must be met for admission. This requirement may be waived if the student's university teaches all courses in English.

Course Enrollment Process

- ISS partners with academic departments and advisors to enroll exchange students.
- Enrollment isn't guaranteed pre-arrival; be prepared to adjust preferences.
- All exchange students must take a full-time load (12 undergrad, 9 graduate) -- 15 OU credits, or 9 – 15 OU credits (if Graduate or Law students*); most courses are 3 credits).
- Maximum allowed is 15 credits.

*Law Students must be enrolled in Law courses

Academic Expectations

- Attend all classes and strive to meet course requirements.
- Failure to participate or make satisfactory progress may jeopardize your stay at OU.

**Arrival, Departure & Orientation**

- **Arrival:** Monday or Tuesday the week before classes start
- **Depart:** Saturday after final exams
- Students can move into campus housing upon arrival; details will be emailed.
- Limited **airport pickup** is available before classes begin; students must arrange their own transport at semester's end.
- Students may enter the U.S. up to 30 days before the program start and stay up to 30 days after it ends.
- Orientation (NISO)

All exchange students must complete the four-part New International Student Orientation:

- Online Pre-Departure Orientation (immigration, health, academics)
- Airport Transport (if available)
- ISS Arrival document submission
- NISO Connection in-person orientation on campus

Housing

- Most exchange students live in **Traditions Square** (4-bed, 2-bath apartments) for **\$3,375/semester** (2025–26 rate).
- Housing is first-come, first-served; preference given to full-year students.
- **Off-campus housing** is limited and better suited for full-year participants.

Estimated Living Expenses (per semester):

- ✓ **Food:** \$400–600/month (meal plans available)
- ✓ **Books:** \$250–800
- ✓ **Health Insurance:** \$1,132 (fall) / \$898 (spring)
- ✓ **Personal Expenses:** \$400–800+/month
- ✓ **Other Fees:** Sooner Card, program/orientation fees, transcript fees
