Letter From The Director

This message is a hello and a goodbye. After 6 ½ year as Director of SLIS, I will be going on sabbatical at the end of this semester and expecting to return to the faculty next year. I am proud of the transformation that SLIS has undergone in the past several years. The changes we have made reflect steps we have taken to align the School with the evolution of the LIS field and also to grow with the institutional changes at the University of Oklahoma. Our internal processes have been guided by an actively engaged strategic plan, new vision and mission statements, and an outcomes-based continuous assessment cycle.

We could not have achieved our goals for the School without our wonderful, hard-working faculty. Although we have sadly bid farewell to some of our beloved colleagues who have retired or left OU for positions elsewhere, we have also welcomed several new faculty with exciting specializations and ideas. Change is, of course, the nature of life whether in one's personal life or the life of an institution such as SLIS.

In addition to our faculty, we could not continue to succeed without the enthusiastic support of our students, alumni, and professional community. YOU make all the difference in our success at many levels, including with the recent American Library Association accreditation review which restored our MLIS accreditation from conditional to continuing.

Students are increasingly coming to the MLIS program with an interest in the intersection of libraries, archives and museums, reflecting the larger conversation in professional circles about the natural overlap of these cultural heritage institutions. We have responded by expanding our archives curriculum and starting an archival studies graduate certificate. In the past few years, we have started working heavily with the OU Master of Arts in Museum Studies (MAMS) both by allowing MLIS students to count some museum studies classes as electives and by supporting the quickly growing number of students pursuing a dual master's degree with the MLIS and the MAMS.

Letter From The Director Continued

The LIS field has long embraced the application of technological advances to information organization, retrieval, and provision. Over the past decade SLIS has invested heavily in building the technology and data science aspects in our curriculum by hiring faculty experts in these areas and launching new academic programs focused on applied technology and data science. Our new Bachelor of Science in Information Science and Technology (BSIST) soared to 134 majors in just four years (93 current majors, others have graduated). We are now building the BSIST on the Tulsa campus and expect the new Tulsa Polytechnic Institute, with which the BSIST will be affiliated, to boost our growth in Tulsa.

We are currently conducting an international search for a new SLIS Director who can continue to dynamically move the School forward. Change means opportunity and we are poised on the brink of this next big opportunity for the School. As I prepare to step down as the Director, I would like to thank all of you for your support of OU SLIS. I am so excited by the possibilities the future holds.

Office Remodel


2018 was a BIG year for the SLIS office. It was the start of an extensive remodel of our entire facility.

Dr. DH Monobe has joined SLIS on the Norman campus as a faculty member and as the MLIS Program Coordinator. 

- Dr. Kun Lu is the Data Scholarship Interim Acting Director Dr. Kun Lu became acting interim director of the Data Scholarship Program in the College of Arts and Sciences on August 15, for a one-year term.
- Dr. Yong-Mi Kim and colleagues (Sailatha Thomas, MD, Dr. Sunny Lee, Dr. Suchi Bhattacharjee, and Dr. June Abbas) received a DISC seed grant. This grant is to discover the reasons why Asians diabetes are paradoxical to the findings reported in existing studies. Asians are 40% more likely to have diabetes despite their low BMI and high socioeconomic status.
- Dr. Yong-Mi Kim presented a paper at the International Conference on Knowledge Management in Germany and published the article in the proceeding. The paper was about how opioid use differently impacted psychiatric disorders between male and female. Also, she had a poster at the conference regarding the Native American's health paradox from an ethnic density perspective.
- Dr. Jiqun Liu's authored research book titled A Behavioral Economics Approach to Interactive Information Retrieval: Understanding and Supporting Boundedly Rational Users" is currently in production. This book brings together the insights from Information Seeking and Retrieval, Cognitive Psychology, and Behavioral Economics, and shows how this new interdisciplinary approach can advance our knowledge about users interacting with diverse search systems, especially their seemingly irrational decisions and anomalies that could not be predicted by most normative computational models. • Dr. Abbas received two IMLS grants! The Institute of Museum and Library Services National Leadership Grants for Libraries program has awarded Abbas, along with coinvestigators Chie Noyori-Corbett, Ph.D., associate director of research and associate professor in the Anne and Henry Zarrow School of Social Work, and Jiening Ruan, Ph.D., professor from the Jeannine Rainbolt College of Education, a two-year planning grant for \$149,994 that will help the team identify the library services most needed by refugee communities. The researchers hope to provide a deeper understanding of the status of refugee programs and services in public libraries, establish partnerships with libraries in refugee communities, and develop a nationally shared prototype of traumainformed care programming for refugees at public libraries.

Authentic learning experiences include tours in Rome and visits to the Coliseum, Forum, Pantheon, the Vatican and St. Peter's Basilica, Florence's Cathedral Complex and Palazzo Vecchio Medici Chapel and other libraries, museums and archives in Arezzo and Siena. 

- Diana Dawson received the Spectrum Scholarship award, a one-time \$5,000 scholarship, from the American Library Association, which provides tuition support and leadership development to graduate library students who are American Indian/Alaska Native, Asian, Black/African American, Hispanic/Latino, Middle Eastern and North African, and/or Native Hawaiian/Other Pacific Islander students. One of their goals is to increase the number of librarians who are minorities by assisting the student with obtaining a Library Studies graduate degree. The award provides support to attend the Spectrum Leadership Institute at the ALA Conference. Dawson shared "The monetary funds from these scholarships removed a great financial burden on my family and me. Attending the Spectrum Leadership Institute at ALA allowed me to network and learn about issues affecting the library community. Diana is also a 2022 Oklahoma Library Association Scholarship Recipient. In addition, she has also been elected Vice-President to the newly formed incorporated regional REFORMA chapter. REFORMA is a 4-state chapter called, Corazón de la Nación (Heart of the Nation) that makes up Oklahoma, Arkansas, Kansas, and Missouri.
