**Catalog Description**: Covers basic concepts of computer system design and communication between components, along with current and historical examples of computer architecture.

**Course Objectives:** Students will develop and understanding of the fundamentals of computer architecture. Students will appreciate current trends and constraints in this rapidly changing field. Students will implement (both individually and in teams) the basic concepts presented in lecture using industry standard hardware design tools. Students will communicate their design decisions and evaluations in written reports and oral presentations.

This course is an intensive introduction to the fundamentals of computer architecture. We will discuss the basic design, or architecture, of computing hardware. Computer systems involve architecture design at many levels. We will focus on the instruction set architecture (ISA) level (the interface between the software and computing hardware) and the microarchitecture level (the computing hardware itself). We will examine to some extent, the level above the instruction set (the programming language level) and the level below the microarchitecture (the logic gate level) in order to deepen our understanding of computing systems.
