- II. IT updates reported by Nick Key
 - A. D2L upgrade time 11:00pm Wednesday, May 18th until complete goal is 24 hours upgrade complete by Wednesday May 20th so system will be down only one business day.

 - B. Opportunities for wireless deployments over the summer. Nick Key requested input from the committee. Discussions included Catlett, Carson basement, Cross Main, Hester Hall, Dale Hall classrooms, Dale Hall Tower (currently getting residual from classrooms), and other general education classrooms on the South Oval. Dale Hall has been identified as a priority to upgrade classrooms during peak times. Access points are designed to support 25-30 students at a time. Problem is with large classes in proximity

of security for a certification program for individuals with access to sensitive
