Accessibility Tech (Jon Kratz and Chellé Lodge Guttery)

- Andy:
  - o Accessibility and Disability Resource Center (ADRC) is a lifesaver for faculty
- Jon:
  - o Accessibility issues usually involve technology
  - o Most of these accessibility issues are of our own making by us choosing vendors that are not accessible
    - One example is our scholarship application
  - o Is there anything we can do as a committee that we can help ADRC?
- Chelle:
  - o Challenges in online programming have accelerated with COVID. Growing rapidly.
  - o Main issue are platforms are not accessible
  - o Vendors are getting better with accessibility
  - o SPSS does have a version that is accessible, but there is a sharp learning curve
  - o We need to let students know what accessible options are available
  - o ADRC is working with Provost Office on getting more accessible textbooks
    - Publishers are not federally funded so they are not required to be accessible
    - We are responsible for choosing accessible materials
    - McGraw Hill Connect is only access if you choose from limited options for a course
      - Connect is functional, but not accessible due to the limited accessible options
    - Working with instructors to know what to asked for when reaching out to publishers
    - Issues in Social Work. No accessible version of a specific textbook. It's
      electronic but uses column format, which screens-readers cannot read
      correctly. ADRC had to retype the textbook to make it accessible.
    - Electronic does not always mean accessible
  - o More and more instructors are using Canvas/D2L even in in-person classes
    - We are starting to go into Canvas/D2L to review course materials
    - Charts and graphs need faculty input to convert to accessible version (need that domain knowledge)
  - o We currently have one full time specialist (Donna) and one MIS intern (Megan) that is graduating in May

- Across all three campuses
- Jon:
  - Your staff levels make it seem overwhelming
  - o Faculty training seem to be a good staring point
  - o What else can we do to help?
- Chelle:
  - o Happy to help look at solutions
  - Looking at Canvas/D2L accessibility audit tool called Blackboard Ally
    - https://www.blackboard.com/teaching-learning/accessibility-universaldesign/blackboard-ally-lms
    - Will make the changes it can make
    - It will flag issues for the faculty. Gives them info on how to fix.
    - It's expensive. How do we share costs?
  - o Donna is the hands-on person (trainings)
  - o If there are departments that need training. Let us know.
- David:
  - o Is the Canvas/D2L audit tool that most important priority for ADRC?
- Chelle:
  - o Yes
  - o Does require and annual subscription
- Andv:
  - o What about web page audits?
- Chelle
  - o Sortsite will allow us to audit web page (\$1400 per year for two licenses)
    - https://www.powermapper.com/products/sortsite/
  - o Will recognize embedded links and images, etc...
  - o Web crawling, not just static analysis
  - o ADRC will purchase two licenses
  - o Can purchase more licenses if needed
  - o National Federation for the Blind uses this
  - o Works better than free accessibility checkers
  - o Saves time
  - o Just started testing it
- Andy:
  - o Most of our web pages are CMS. How does ADRC with with that system?
- Chelle:
  - o We work with the Marketing and Communications to make adjustments as needed
  - o CMS usually has contrast issues
  - o Users have lots of color options that can cause contrast issues and there are some contrast issues baked into templates.
- Nick:
  - Digital Innovation Team works with Chelle's team on the internal application side to make them access.
- Andy:
  - Does blackboard Ally look at plugins?

- Chelle:
  - o More limited, but it does look at them.
- Andy:
  - o MyMedia videos are used more now than ever
  - o Default captioning system does not seem to do a good job
  - o Can we work with ADRC for better capturing
- Chelle:
  - We have after-the-fact caption in MyMedia, but much of that text needs to be modified.
  - o Or we have Verbit (live caption), AI tool to allow live capture and live edit
    - https://verbit.ai
  - o Or we have Rev
    - https://www.rev.com
- Andy:
  - o Any immediate needs?
- Chelle:
  - Just awareness
  - o Auto captures in MyMedia is okay, but not good enough. It really does require edits especially in jargon heavy disciplines like STEM
- Andy:
  - o Do instructors interface in with captioning just in MyMedia?
- Chelle:
  - o Yes, but for post caption. Live caption goes through Verbit.
- Andy:
  - o Anything else you need from us?
- Chelle:
  - o Continue to grow collaboration and de-silo accessibility efforts
