Petition Filed by Election Commissioner Baylor Savage FA24-01 Decided October 16th, 2024

#### **Holding**

4-0 In Favor of Petition

#### **Facts of the Petition**

**FA24-001** was submitted to the Student Government Association Election Commission on October 14th by Election Commissioner Baylor Savage. It was filed against Diego Fazzani, Jeffrey Ogle, and Madeline Cantrell. A formal petition was filed via email against the 3 candidates with them each getting an opportunity to respond to the petition. The petition alleged that the 3 candidates did not attend the mandatory informational despite being told multiple times via email that it was mandatory and giving them options to do so. After holding a meeting for review of FA24-001, the Election Commission determined that the candidates committed a Class A infraction by not attending the mandatory informational meeting. The Election Commission determined the candidates who didn't attend the mandatory informational should be assigned 3, 2.5, and 2 points, respectively, due to this infraction.

#### Discussion

When determining the Class A infraction, the Election Commission considered how many points should be awarded to the people deemed to not attend the mandatory informational meetings. The points were determined by the rationale that Madeline Cantrell made an effort to respond and meet with the commissioner, Jeffrey Ogle attempted to respond after the period of mandatory meetings,

and Diego Fazzani did not attempt to address the petition at all. As a result, the commission felt it necessary and proper to award Madeline 2 points, Jeffrey 2.5 points, and Diego 3 points.

It is so ordered.

#### **SGA Election Commission**

Petition filed by Election Commissioner Baylor Savage FA24-002 Decided October 28th, 2024 3-0 In Favor of Carter Strickland and Avery Dunlap.

#### **Facts of the Petition**

**FA24-002** was submitted to the Student Government Association Election Commission on October 25th, 2024, by the SGA Election Commissioner via the "Election Formal Petition Form Fall 2024. This form was established in accordance with the SGA Code Annotated to provide SGA members an electronic form for reporting suspected campaign infractions. The petition states prior findings by the Commission that candidates Carter Strickland and Avery Dunlap failed to file reports that were correct and complete in form, in violation of the Code. SGACA Tit. VI Ch. 4 § 5(b)(vi). The petition alleged that photographs taken for the campaign were not listed at fair value for expenses. While the submitted cost was \$20, a quote obtained by the commission from the same photographer was \$100. Upon review, each of these candidates was named as a Respondent to this petition and informed that they had 24 hours to file a response or request an oral hearing. In Carter's response to the petition, he explained that the pictures were taken on September 9th, a month before the photographer began his business.

#### **Discussion**

When determining the Class B infraction, the Election Commission considered all available facts and ultimately relied on the timing difference in their decision. Because the photographer had not yet begun his business, it is entirely possible his rate changed through the time period. The commission found that there were no malicious or intentional hiding or fraudulent expenses recorded. No infraction points were given.

#### **SGA Election Commission**

Unofficial Notification v. Jael Finley FA24-003, Decided October 28th, 2024 **Holding** 

**Election Commission Decided to Dismiss** 

#### **Facts of the Petition**

**FA24-003** was submitted to the Student Government Association Election Commission on October 27th, 2024, by Elias Hallum via the "Unofficial Election Notification Form Fall 2024." This form was established in accordance with the SGA Code Annotated to provide SGA members with an electronic form for reporting potential campaign infractions. The notification alleges that Jael tore down/ destroyed Elias' posters in Couch tower, which is an infraction of the SGA code. Elias claimed that a poster that he had put up near one of Jael's posters was ripped up and Jael's poster was not. Upon reviewing the evidence, the notification against Jael was dismissed.

### **Discussion**

The Election Commission reasoned that there was no proof Jael was involved in any of the alleged actions. Elias includes in his notification that the RA's of Couch mistakenly removed his posters throughout the building. Furthermore, simply having a poster in the vicinity of another that is damaged does not indicate guilt. Ultimately, the commission agreed that there was a lack of any substantial evidence to pursue the notification.

The petition states prior findings by the Commission that several candidates for office in the Fall SGA General Elections failed to file initial financial reports that were correct and complete in form, in violation of the Code. SGACA Tit. VI Ch. 4 § 5(b)(vi). Upon review, each of these candidates was named as a Respondent to this petition and informed that they had 24 hours to file a response or request an oral hearing. Some candidates submitted their financial reports after being put on notice, and the petition against them was dismissed.

#### **Discussion**

When determining the Class B infraction, the Election Commission considered who did and didn't submit a financial report at all. Greenlee, Martin, and Ryne did not submit points, nor did they respond within the 24-hour notification window, and thus received 2 points.

It is so ordered.

The petition states prior findings by the Commission that several candidates for office in the Fall SGA General Elections failed to file initial financial reports that were correct and complete in form, in violation of the Code. SGACA Tit. VI Ch. 4 § 5(b)(vi). Upon review, each of these candidates was named as a Respondent to this petition and informed that they had 24 hours to file a response or request an oral hearing. Some candidates submitted their financial reports after being put on notice, and the petition against them was dismissed.

#### **Discussion**

When determining the Class B infraction, the Election Commission considered who did and didn't submit a financial report at all. Greenlee and Martin did not submit points, nor did they respond within the 24-hour notification window, and thus received 2 points.
