VALIDATION OF THE ELECTION REPORT AND RESULTS OF THE 2024 SPRING STUDENT GOVERNMENT ASSOCIATION ELECTION

[APRIL 9, 2024]

CHIEF JUSTICE WALLS delivered the unanimous opinion of the Court.

The Court has not received any appeals to the Election Report nor has the court been presented with any evidence that there is any administrative irregularity in the Election Report. Further, the court has not been notified of any outstanding, unresolved, or pending complaints or infractions related to the Spring 2024 Election of the Student Government Association. The Court reviewed the Election Report—and, in accordance with SGACA Tit. VI, Ch. 5, §12, maintained a presumption of administrative regularity—and identified no substantive or consequential issues related to the Election Report. The Election Report, as was approved by the Court, is attached as an appendix to this document. The 2023 Student Government Association Election Report is hereby validated.

## **Facts of the Petition**

**SP24-001** was submitted to the Student Government Association Election Commission on March 4th by Election Commissioner Seth Phung. It was filed against Laura Calvert, Caren Ho,

Tucker Dunn, Michael Reynolds, Brooklyn Schroeder, and William Beasley. A formal petition was filed via email against the 6 candidates with them each getting an opportunity to respond to the petition. The petition alleged that the 6 candidates did not attend the mandatory informational despite being told multiple times via email that it was mandatory and giving them options to do so. After holding a meeting for review of SP24-001, the Election Commission determined that the candidates committed a Class A infraction by not attending the mandatory informational meeting. The Election Commission determined the candidates who didn't attend the mandatory informational should be assigned 2 points due to this infraction.

## Discussion

When determining the Class A infraction, the Election Commission considered how many points should be awarded to the people deemed to not attend the mandatory informational meetings. The points were determined by the rationale that the candidates didn't respond to any emails or warnings, nor made any attempt to set a day for a meeting. As a result, the commission felt it necessary and proper to award 2 points

# **SGA Election Commission**

Hanaa Saidi v. Kennedy Corbin SP24-002 Decided March 31st 2024

#### **Holding**

3-0 in favor of Kennedy Corbin

## **Facts of the Petition**

**SP24-002** was submitted to the Student Government Association Election Commission on March 20, 2024, by Hanaa Saidi via the "Election Formal Petition Form Spring 2024." This form was established in accordance with the SGA Code Annotated to provide SGA members with an electronic form for reporting potential campaign infractions. Upon receiving the petition, the Election Commissioner determined that candidate Kennedy Corbin were implicated in the complaint and informed the candidate of the petition that had been filed. The conduct in question was submitted as a petition under the belief that it fell under *SGACA* Tit. VI, General Rules 2(a), as a "Class B Infraction." The petition alleges that because Kennedy Corbin posted a campaign post on her Instagram during Spring Break, she was breaking the rules of campaigning outside the time period. After notifying the accused, the Election Commission met to discuss the matter. It was determined that the Corbin campaign had not participated in any such conduct to warrant an infraction.

#### **Discussion**

The Election Commission reasoned that the intent of the time frame for the voting period was more so to prevent people from campaigning before or after the allowed time period. Since Spread Break is between the beginning and end of the time period, it's fair game in terms of being allowed.

Avery Dunlap v. Kennedy Corbin SP24-003 Decided March 31st 2024

## **Holding**

3-0 in favor of Kennedy Corbin

#### **Facts of the Petition**

**SP24-003** was submitted to the Student Government Association Election Commission on March 29, 2024, by Avery Dunlap via the "Election Formal Petition Form Spring 2024." This form was established in accordance with the SGA Code Annotated to provide SGA members with an electronic form for reporting potential campaign infractions. Upon receiving the petition, the Election Commissioner determined that candidate Kennedy Corbin were implicated in the complaint and informed the candidate of the petition that had been filed. The conduct in question was submitted as a petition under the belief that it fell under *SGACA* Tit. VI, Chapter 5 Article A-2 as a "Class A Infraction." The petition alleges that student workers were campaigning on Kennedy's behalf while on duty. Specifically, endorsements of Kennedy done by workers were on Kennedy's website during work hours. The petition alleges that because the endorsement was up while they were working, this was essentially campaigning during work hours. After notifying the accused, the Election Commission met to discuss the matter. It was determined that the Corbin campaign had not participated in any such conduct to warrant an infraction.

## **Discussion**

The Election Commission reasoned that the intent of that portion of the Code Annotated is to prevent on job workers from campaigning while working. It would be unreasonable to expect that students couldn't have endorsements online while at working hours. If enacted, it would force campaigns to take down endorsements by student workers during their work hours. This is not an ideal outcome, so the Commission voted the way it did.

## **Facts of the Petition**

**SP24-004** was submitted to the Student Government Association Election Commission on March 29th, 2024, by the SGA Election Commissioner via the "Election Formal Petition Form Spring 2024. This form was established in accordance with the SGA Code Annotated to provide SGA members an electronic form for reporting suspected campaign infractions. The petition states prior findings by the Commission that several candidates for office in the Spring SGA General Elections failed to file initial financial reports that were correct and complete in form, in violation of the Code. SGACA Tit. VI Ch. 4 § 5(b)(vi). Upon review, each of these candidates was named as a Respondent to this petition and informed that they had 24-hours to file a response or request an oral hearing. Some candidates submitted their financial report after being put on notice and the petition against them was dismissed.

#### Discussion

When determining the Class B infraction, the Election Commission considered who did and didn't submit a financial report at all. The ones who didn't submit a report got 1 point.

Unofficial Notifications v. Kennedy Corbin SP24-003, Decided April 3<sup>rd</sup> 2024

## **Holding**

**Election Commissioner Decided to Dismiss** 

## **Facts of the Petition**

**SP24-3** was submitted to the Student Government Association Election Commission on April 3<sup>rd</sup> 2024, by Amelia Landry via the "Unofficial Election Notification Form Spring 2024." This form was established in accordance with the SGA Code Annotated to provide SGA members with an electronic form for reporting potential campaign infractions. The notification alleges that Kennedy was campaigning via a website hosted by OU IT, which is an infraction of the SGA code. The message sent out asked the person to share Kennedy's campaign message with her committee members. Upon reviewing the code and the message, the notification against Kennedy was dismissed.

#### **Discussion**

The Election Commissioner reasoned that the conduct that Kennedy engaged in was not campaigning, but asking a colleague to relay a message to others. It was not asking the recipient to vote for her, just to spread Kennedy's message to the people in her committee. The recipient did not have to send the message if she didn't want to and could choose to ignore it. For this reason, the Election Commissioner dismissed the petition.

Unofficial Notifications v. Hanaa Saidi SP24-004, 005, 006 Decided April 3<sup>rd</sup> 2024

# **Holding**

Election Commissioner Decided to Dismiss

# **Facts of the Petition**

**SP24-005, 006, 007** was submitted to the Student Government Association Election Commission on April 3<sup>rd</sup> 2024, by Natalie Armour, Cambridge Corbin, and Kennedy Corbin via the "Unofficial Election Notification Form Spring 2024." This form was established in accordance with the SGA Code Annotated to provide SGA members with an electronic form for reporting potential campaign infractions. All three notifications arose from the same cause of action and event so they are grouped together here for simplicity's sake. The notification alleges that Hanaa was aggressive and engaged in conduct that was aggressive and seemed forceful in having people to vote for her for CAC chair. Upon viewing the totality of the circumstances, the Election Commissioner decided to dismiss the complaint.

#### **Discussion**

The Election Commissioner reasoned that while Hanaa was being aggressive, she was not actively forcing people to vote for her. Pressure is not the same thing as forcing someone to vote for you. For this reason, it was concluded that Hanaa was probably coming off as aggressive, she was not forcing people to actually vote for her.
