CONGRESSIONAL BILL CB-114-01 SENATE BILL GF25-01

#### AS INTRODUCED

An Act of Legislation appointing the 2025 General Counsel; providing for short title, providing for codification, and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

**Section 1:** Title: This act shall be known and may be cited as the "Fall 2025 General Counsel Appointment Act."
