-CR-108-18 "Salute to Veterans Parking Act" (Reynolds/Kathuria) (U-Pol, Rec of Do Pass)

Motion to see CR-108-18

Representative Griffin seconded by Representative Reese

- Author's Explanation (Reynolds): This is my first bill. There are only four parking spaces for veterans on campus including north and south campus. We are trying to see if we can increase the parking spaces for student veterans because a lot of them don't have handicap stickers and they may have PTSD. They have already served the country. We are requesting nine more spots to represent 13 for the 13 stripes in the flag. We are also we requesting that if they are a student veteran they have a designated parking tag.

2:00 yielded to questions

- **George:** Did you ask Chris?

- I did, and he said no. He said there was already enough. One in one garage, one by the north oval, and two over by the union.
- **Robinson:** How many veterans do we have on campus?
 - We have 1,200+.
- **Haskins:** Do you intend for the parking spaces to be spread out?
 - Yes I want them spread out. There should even be some at our north campus since there are veterans out there flying.
- **Lewis:** Did you talk to parking services about the pass as well or just the spots?
 - Just the spots, which is why this would be sent to parking services.

17-0-0 unanimous pass

-CR-108-19 “Voicing Our Thoughts Electorally/V.O.T.E Act” (Lewis/Lissau/Griffin) (EA, Rec of Do Pass)

Motion to see CR-108-19

Representative Griffin seconded by Representative Reynolds

- Author’s Explanation (Lewis): This calls on the administration and the university to recognize voting exemptions for students who may not have the means to miss class. There was positive feedback from administration, and we want to keep the door open. It was a bit too close to election time when we first started having these conversations. This could open the door for it being added to the faculty handbook.

1:45 yielded to questions

- **Kathuria:** Would voting exemptions count for elections outside of November?
 - Yes.
- **Reynolds:** Are you thinking about a voting holiday for main elections?
 - This would not be a holiday but give people a chance to have an excused absence for classes.
- **Trautman:** Can you please explain why this bill was not presented before this election?
 - This has been in the works for a long time. We wanted to get support from the administration when presenting our statement and we felt that as SGA we should see this resolution after our statement. We did not want to upset them before putting this resolution out there.
- **Kathuria:** Is it in your opinion that the president-elect should be sent a copy of this resolution as well?
 - Yes, I would be in favor of an amendment for that.
- **Kathuria:** Would you be in favor of a friendly amendment to section 7 adding President-Elect Chris Firch.
 - Yes.
- **Haskins:** Is the plan to bring polling locations to campus still a thing?
 - Yes, and there is so much that goes into that. The Cleveland Election Board must notify people 30 days before an election that their precinct site is changing. We were 8 days from that window and felt it was too little time. They are open for doing it next semester.
- **Griffin:** Why did you feel it was the best decision not to go into a voting holiday.
 - After talking to further directors, it seemed as though voting holidays would encourage them to talk to us less because they would see it as though we are asking for too much. Holidays are placed in the calendar years in advance.

That would be more of a conversation to have OU/TX become a fall break so that SGA can use that holiday for election day.

Representative Kathuria seconded by Representative Reynolds

- **Halsey-Kraus:** Will you accept me as a co-sponsor?
 - Yes.
- **Kathuria:** There have been limitations in polling sites for some individuals. Do you believe professors are aware of the implications of having limited polling sites
 - Yes, I think professors recognize that and in my opinion it's not about faculty pushback its more about the logistics of what goes into it. It's more about the messaging because nobody wants to tell faculty what they have to excuse.

AS INTRODUCED

A Concurrent Resolution recommending OU parking services to increase the number of veteran parking spaces on campus; and providing for distribution.

Whereas: As of today, there are only 4 total parking spaces available for students who are veterans; and

Whereas: Veterans deserve to be treated with the utmost respect for the services they have provided to our country and the community; therefore

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE STUDENT GOVERNMENT ASSOCIATION:

Section 1: Title: This resolution shall be known and may be cited as the “Salute to Veterans Parking Act.”

Section 2: The University of Oklahoma Student Government Association recommends that OU parking services do the following:

1. Increase the number of designated parking spaces to thirteen spots to represent the thirteen stripes of the American flag.
 - a. Designated parking spots should be placed in any parking garage or parking space on campus.
2. Have a designated commuter parking tag for each qualified student veteran on campus.

AS INTRODUCED

A Concurrent Resolution to encourage the University
of Oklahoma to recognize voting exemptions for
students; and providing for distribution.

- Whereas: The University of Oklahoma's Strategic plan makes frequent references to the promotion of civic participation and engagement to create a more democratic society¹; Therefore
- Whereas: It is important that the University of Oklahoma and the Student Government Association partner together to encourage civic engagement amongst students; and
- Whereas: Students historically have made up a very small percentage when compared to the number of eligible voters who actively participate in voting²; and
- Whereas: We have the unique opportunity to make a significant change and allow students to have a voice in the 2022 midterm elections; and
- Whereas: The University has recognized the importance for Staff to vote by granting them two-hour voting exemptions from work³; and
- Whereas: Administration should recognize the same rights for students; and

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE
STUDENT CONGRESS AND THE GRADUATE STUDENT SENATE, CONCURRING
THEREIN THAT:

The University of Oklahoma's Second Pillar serves to, "Prepare Students for a Life of Success, Meaning, Service, and Positive Impact." This pillar closely relates to the promotion of Civic Engagement. Under the strategies used to preserve Oklahoma's Second Pillar strategy 4, tactic reads:

"Tactic 3: Set clear service learning, volunteerism, and leadership expectations in the student experience for everyone¹." Voting is the most basic leadership and service expectation that one can fulfill as a student.

Section 1: Title: This resolution shall be known and may be cited as the “Voicing Our Thoughts Electorally Act.”

Section 2: The University of Oklahoma Student Government Association strongly encourages the creation of Voting Exemptions for students for future elections. Voting exemptions are needed for a multitude of reasons that include:

1. Forty-four percent of students are non-residents, and 5,669 of these students who vote in Texas.⁴
2. Casting a ballot may take hours because of long poll lines.⁵
3. Many students prefer to vote in person.

Section 3: The University of Oklahoma Student Government Association suggests creating new university policy, modeled on Section 3.15.2 of the Faculty Handbook, to permanently protect the civic responsibilities of students from adverse academic consequences, to be added as section 3.15.3 of the faculty handbook as follows:

"It is the policy of the University to excuse the absences of students that result from civic participation, such as voting and participation in jury duty, and to provide without penalty for the rescheduling of examinations and additional required class work that may fall on days of civic duty."

Section 4: The University of Oklahoma Student Government Association also recommends leaving any requirement regarding presenting proof of voting to the discretion of the faculty member.

Section 5: Student employees should be entitled to a similar exemption as enumerated below in the Staff Handbook:

“Every employee shall be allowed two hours of time during the period when an election is open in which to vote. If an employee lives at such a distance from his or her voting precinct that more than two hours are required to attend the election, then the employee shall be allowed sufficient time to cast a ballot. Employees shall only be provided this time to vote upon oral or written notification to a supervisor on the day preceding the election. Upon proof of voting, no employee shall lose compensation or otherwise be penalized for the absence.”⁶

Section 6: The University of Oklahoma Student Government Association urges the Faculty Senate to create a resolution of support for the adoption of voting exemptions for students.

AS INTRODUCED

A Concurrent Resolution recommending the raise of
student wages across University employment; and
providing for distribution.

- Whereas: The University of Oklahoma student wages are currently between \$7.25 - \$10 depending on the area of employment⁷;
- Whereas: According to Living Wage Calculator from the Massachusetts Institute of Technology, the livable wage for a single adult in the State of Oklahoma is \$15.75⁸;
- Whereas: According to the 2021 Census, 16.9% of the Norman population is below the poverty line;
- Whereas: The University of Oklahoma is the largest employer in the City of Norman⁹;
- Whereas: The University of Oklahoma has struggled to maintain consistent numbers of student employees throughout the 2021-2022 Academic Year;
- Whereas: Universities such as University of Maryland, University of Notre Dame, and Johns Hopkins University have raised student wages to reflect a more sustainable living wage;
- Whereas: According to Pew Research, two-thirds of Americans (67%) support raising the minimum wage to \$15 an hour¹⁰;
- Whereas: The University of Maryland raised the student wage from \$12.50 to \$15, with 30,000 students enrolled and average tuition of \$38,000¹¹;

- Whereas: The University of Notre Dame raised the student wage from \$11 to \$15, with 9,000 students enrolled and average tuition being \$58,000¹²;
- Whereas: John Hopkins University raising the student wage to \$15, with 23,000 students enrolled and average tuition being \$58,000¹³;
- Whereas: According to the Federal Reserve Economic Data, the federal minimum wage has remained stagnant for the past twelve years¹⁴;
- Whereas: The minimum wage in the State of Oklahoma has maintained a consistent minimum wage of \$7.25 since 2009;
- Whereas: According to The Hill, most students believe a \$15 minimum wage would “improve standards, increase financial freedom, increase the ability to save, easier student loans payoff, and affording better food¹⁵,”
- Whereas: The number of student employees has significantly dropped, with 4,275 student employees working in 2017¹⁶;
- Whereas: With the University of Oklahoma employing 3,758 student employees in 2018¹⁷;
- Whereas: With the University of Oklahoma employing 3,500 student employees in 2019¹⁸;
- Whereas: With the University of Oklahoma employing 2,569 student employees in 2020¹⁹;
- Whereas: With the University of Oklahoma employing 2,812 student employees in 2021²⁰;

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE STUDENT CONGRESS AND THE GRADUATE STUDENT SENATE, CONCURRING THEREIN THAT:

Section 1: Title: This resolution shall be known and may be cited as the “Workforce Action and Gainful Employment (WAGE) Act of 2022.”
