Approval of Minutes | April 8, 2025 Officer Reports –

Within our interview, I remember thinking, "Wow, these two have way better answers than me, and thank God I didn't get asked about Robert's Rules." After the first meeting, I found myself walking back with Aaron and Chloe, and all three of us came to the conclusion that Congress is a cult. We all hated our first meeting and actively complained about how awful it was. For some odd reason, I always felt this tugging to come back. Slowly, I decided to just keep doing more. I decided to run as a Representative in a now removed district because I was urged by Amelia Landry and I have much of my success due to her. Back then, however, that room was able to house all of us with no problems whatsoever. Congress today is bigger than before. It's also a lot better. We actually take initiative and remove individuals who are not doing what is expected of them. We have calls for debate, we have people voting no on certain bills, we have votes of no-confidence. It seems normal now, but it wasn't always like this. During my freshman year, we had very few calls for debate, very few no votes, and nothing even close to a vote of no-confidence or a presidential impeachment. This was a really unprecedented semester, and I encourage all of you to keep doing unprecedented things. If I had to give one piece of advice to you all, it is to stand your ground. Do not let articles by the OU Daily, gasps from other people, or dirty looks from your fellow Congress members ever stop you from voting for what you believe in. I've been through it before, twice actually, when I was the only person to vote against CR-111-03, the Diversity, Equity, and Inclusion Matters Act, as well as when I was the only person to vote against CR-113-05, the Women's History Month of 2025 Act. I got lots of interesting looks from my fellow Congress members during the roll call vote for both bills. My name and the way I voted made it to the OU Daily both times. It wasn't all that bad. I would do it again. Abandoning what you stand up for is far, far worse. It creates a Congress that is lame, one that doesn't really stand for anything. As I graduate, I want all of you to keep Congress exciting. Do not purposely create drama, but do not abandon what you believe in simply to maintain conformity. As I leave this body, I just want to say thank you to everyone who has helped keep. Congress alive. The OU College of Medicine, where I will be attending next semester, technically has a Student Government Association, but it is a shell of what we see here. Congress was the first club I joined here at OU, and it is the last club that I will be leaving. Robinson- Good evening everyone I want to start with something simple. Thank you. Thank you for being here, thank you for being a member of this body and thank you for still believing that student government can make a difference. My name is Caleb Robinson and I am going to be your next Congress Chair. Not for the opportunity but for the opportunity to serve because I believe in Congress because I believe in each and every one of you. Since 2018 I have carried a small part of my wallet that I promise to make a difference because I said I would. I wrote these words in a moment where I didn't know where my path would take me, but I knew exactly the type of person I wanted to be. And this card has guided me in every single decision I have made in leadership up until now. This role that I hope to undertake is not just about procedure it is about people. This link will bring you to the links that we already have like bill formats and other resources that I will implement like bill writing night and a parliamentary procedure writing guide. I also want to create a Congress calendar or an SGA calendar because I want to interact with GSS and the Executive Branch to make sure that every event you could possibly imagine is right there accessible both to you and the student body. As your chair I will also make sure that all the resources are easily accessible to empower each member to succeed and grow. Then collaboration, collaboration is about fostering an environment about teamwork and inclusivity. Every voice matters and as your Chair I will ensure that all members regardless of experience are encouraged to contribute to discussions and decision making especially when it comes to bills and other initiatives. I will implement an anonymous feedback form and will always be the last to leave congress every night. I want to make sure that even if you cant come to my office hours you have access to me and my time personally every single Tuesday night. As we have seen this year it is also important that leadership has ample opportunities to have their performance reviewed. So I would implement a mid-semester review for Congress exec meaning that we would have peer reviews essentially just giving everyone an automatic opportunity to grow and learn in their position rather than letting it get to the very end whenever they didn't do their job and we have to remove them from their position. Next step understanding. It is important that all members have a thorough understanding of parliamentary procedure, bill writing, and how our branch interacts with others. This would mean that every single member of the body would have access to information that I have, that our vice chair, or secretary and all of exec. I want to make sure that all of you have the same tools that I do to make sure that you're successful. I also want to focus on working with committee chairs to make sure that they are subject matter experts on everything to do with Congress. I love our committee chairs and I have to agree that I think this is the best set of committee chairs that we have ever had, but I think it is really important to make sure that they know everything about Congress and not just everything about their committee. And finally Streamlining. I plan on adopting a new system for recognizing questions and generally chairing as efficiently as possible. The new system of question recognition would essentially make it to where you would be able to raise your hand, have your name placed on a questions list and be recognized in the order that I see your hand. This would just make things run a little smoother and you wouldn't have to worry about getting your hand up first whenever it is time for the next question. I would also institute a voice/hand votes for votes and motions that just generally would the body move faster so we could hopefully get out of here before 12 o clock tonight. Finally I will do everything that I can to ensure that our body continues to grow that every member of Congress is given a voice. That you are each given the tools that you need to succeed over the coming year and that we ensure that each and every one of you is able to go home as early as

possible. I am dedicated to receiving and implementing as much input from you as possible and I hope to earn your vote thank you.

- **Kathuria** What does it mean in your view to win for Congress and to win for the everyday OU students?
 - Schonfield- I would say that as far as what define winning for Congress and the student body. I would say that the best way that we can win for the student body is by interacting with them as much as possible. That is a big part of what I was discussing in regard to tabling. I want to make sure that we have every opportunity, especially for exec to communicate with the student body, but generally for us to interact with everyone as much as possible, get feedback from our students and overall know exactly what they are passionate about and what they would like to see so that we know what we need to be doing. Additionally I don't know about you guys but I like meetings and everything really to run as smooth as possible. So I just want to do everything that I can to make sure that every process in Congress meetings, every process in committee meetings and everything is between for Congress runs as efficiently and as smooth as possible so that is what I would define as winning.
 - **Robinson** I think winning for the student body is about listening it is about being intentional it is about actually meeting with them. Like he mentioned I think we have some different approaches to this. I think for the most part we do need to focus on tabling intentionally and tabling regularly. I mentioned this just recently in my speech but going out there whenever applications aren't due, not going out there just election cycles because when we are out there during election cycles they see that we are there and we are asking them to do something for us. We are not sitting there asking them what their problems are and showing what we have done. So what I would like to do is meet with every committee chair, compile a list of projects, compile a list of legislation and give that list so that we can show that list while we are tabling and doing this at least once a month. One this provides a great CSP opportunity for all of you and number two that gets out there pretty regularly and of course a lot of these approaches are kind of double pronged so while we are out there, they see that we are being intentional, they know about us they are seeing that we are actually doing things. We don't have the questions of what does SGA do because we are out there actually advocating for what we do regularly. And so when people are interested this will also boost our recruitment and then at the same time, I would also look at doing bimonthly town halls this would be two per semester. I had a sheet that I would like to send to you all after these questions. This has some of the themes some of the dates and this would give us an opportunity to bring in people from the executive branch, to bring in administration, certain faculty all of these would be themed like in November for example would be about mental health because I think helping provide these resources while also giving them an opportunity to voice some of their issues and ask us some questions. It's a great double effect and then for winning for Congress. One of the biggest things that I wanted to do, hitting on efficiency as well is implement an electronic voting system with the option at the very end of would anyone like to change their vote, just in case the second issues. If you a nerd like me, if you've looked at some of our peer SEC schools, most of them do have electronic voting systems, faculty senate has

- electronic voting systems, so I think this would speed up the process especially as our body continues to grow as it has over the past two years.
- **Koneru** What do you think is the biggest problem that Congress is facing right now? To clarify if there is multiple what would be your priority to address?
 - **Robinson** I think one of the biggest issues we have faced right now is this crisis among the student body of what does student congress do. So in the wake of the impeachment, in the wake of the no confidence vote, a lot of the members of the student body, a lot of the students just kind of had the name SGA or had the name Congress or had President thrown at them from the OU Daily or through certain social media apps but there was not much discussion over what we actually did. Most people said they didn't know where to find our minutes, how to find bills, how to see agendas, who their representatives were, so I have heard a lot of talk in the office about some people who here recently had an uptick in people ask who is my representative, how do I contact them. So I think that really is one of the biggest issues. It is not transparency, it is accessibility. I think we as a body are already pretty transparent. The issue that we run into is I don't think we are very clear and I don't think that a lot of our things are openly accessible. I mean most students don't really know where to look. We have them on the SGA website, we have them on Engage, but people aren't really familiar with those, how to navigate those, or even knowing that they exist. So I think advertising those and putting more work into both focusing on recruitment and at the same time this is where you can find our resources. I think that is a very important thing for us to focus on right now.
 - Schonfield- I kind of have to second as what he sees as the most important issue facing us as Congress and SGA generally. It is definitely a problem whenever what everyone associates what we are doing is this one big glaring thing called an impeachment. I think what we can do to combat that is on some level is really I have to agree with Caleb on most of it. It is really a big problem, not regarding transparency. You can find our agendas and minutes online it is really not that difficult to type in OU SGA. It is really a matter of making sure that they know who we are and what we are doing. And like I said in my speech earlier, I think tabling and info sessions are a big part of that. I think that is very important. Part of what I do to address that and make sure that we are out there and everyone knows who we are and what we are doing is by requiring every member of the executive committee including committee chairs and big 3 to have a higher threshold, a higher level of requirement regarding tabling and otherwise as much as tabling you know providing tabling opportunities for people is really useful. We have done tabling before in Congress and just not gotten a lot of engagement with members regardless of whether or not they needed a CSP. So my solution to that is you know still offering it to the general body to go out and table to make sure that people know who we are what we are doing and what we can do for them, but also making sure that we do have people that are both knowledgeable, confident, and willing to show up at those tables and are making sure that they are interacting with the student body.
- **Cunningham** As members of Congress a lot of us are involved in other RSOs and organizations I am wondering what are your involvements on campus? How would you rank them including Congress?
 - O **Schonfield** I am only in the Oklahoma Intercollegiate Legislature and Congress. These are the only two things that I am a part of on campus. I would absolutely have

- to rank Congress higher on my list of priorities. I was just recently elected the Governor of the Oklahoma Intercollegiate Legislature meaning that I am in charge of the entire statewide competition, but I would like to point out with that, that it is not a paid position, and it also is not one that takes a lot of time. All I have to do in that position in that role is to essentially book hotel dates and session dates and then I go to session for 5 days which doesn't even overlap with Tuesdays. So super easy hands-off position that I managed to win, managed, and honestly, I would absolutely say that it ranks lower. I have gotten a lot of good experience with OIL, and I really love it but absolutely Congress is more important to me. We have a real impact here; we actually do things and I am getting paid to be the WAM Chair and hopefully would be getting paid to be your Congress Chair.
- **Robinson** I don't have a ton of engagements anymore. Freshman year I came in I was gung-ho I came from big pasture that was my high school there were 12 people in my graduating class we did not have a ton to do. So when I got here and saw that there were actual options and I felt like I had to do everything, that just is not effective it means that you are just trying to put a little bit into everything, and I think it is just more effective for me personally to put everything into one specific organization. So right now, my primary focus outside of Congress because we are familiar on Engage, I am a member. This is the only RSO that I am truly engaged with, outside of my academics and my work, I do work with the registrar. This is something that should I be elected I would of course leave that position because this is something that I would like to continue putting my all into so this is my primary engagement and to rank them Congress and then work of course, but that is not something I would be involved in, but going back to what we saw in the previous Vice Chair elections of course my academics do come first. I am interested in going to graduate school, so I want to continue maintaining my grades, putting in that work, so of course my academics do come first but other than that I am not involved in any other RSOs.

On a motion to extend time for questions by 30 minutes Vedra seconded by Hallum

- **Bento** I know while both of you will strive to hit every single point in your platform, if you could only get one thing done on your platform, what would that be?
 - **Robinson** One thing. Okay so, I think I really want to break it down to the bimonthly town halls. So, this is something that we often see people campaign on, but it's not something that is often executed because there's a lot of time requirements in this position. And that's why this is something that I'm looking at, one, just doing bimonthly, this is twice a semester, because this allows me how to encompass a lot of parts of my platform. So, I have the you said we did tracker, which is focused on ensuring students are aware of where their student concerns are at in the process, what committee it is being referred to for the sake of transparency same thing with the bill dock, the bi-monthly town halls allow me to just say that to people. That allows me to still get the information out there while using this as an opportunity to promote certain services from the ADRC, from the University Council Center. So I think this is going to be that would be my go to is the bi-monthly town hall because I think it's something especially in the way like we've mentioned the impeachment so many people are aware of what student government is. I think having this opportunity to engage with this us one on one to engage with professionals, to engage with administrators and faculty is something that would really benefit the

- student body a lot. So using this as an opportunity to kind of push the rest of parts of my platform without directly implementing them, I think that would be my go to.
- Schonfield- If I had to choose one to focus on and I guess make sure that I accomplish if I am not going to do that rest. I would have to say that future point specifically tabling, information session, and generally focusing on recruitment and retention and generally creating a positive environment in Congress. I think one of the most important things that we can do is like Caleb said creating more awareness and interaction with the student body and that is a big thing that I want to do with tabling and information sessions that I have drafted there. Actually having a process by which to get those tables to have good members behind the table, getting that interaction face to face with the student body, getting opportunities not just to do improvement but to do you know ask questions about what we can do for them and show them what we have done. I think that is probably the most important part of my platform because it is about the future and what the future of Congress is going to look like and although I do plan on accomplishing every single one of my points that one has the most long term effect and that's why I think that would be the one I chose over the rest of them.
- **Donald** If you had to rank committees in terms of which ones is most important how would you?
 - o **Schonfield** I am going to be a coward and say that I am going to refuse to rank them. Every single committee in Congress brings something extremely important to the table and we could not be a successful Congress without a single committee.
 - O Robinson- Yeah so I am going to go and follow his coat tails on that one. I saw the vice chair election I am not falling into that trap. Like he said there is a lot that each committee does, you know HD you guys specifically in the wake of general global political scale right now. There is a lot going on right now. SUSTY following the same kind of root of accord there is a lot going on with the EPA. There is a lot that you all have to take on now. Every single one of you serve in extremely important and distinct purposes because all of these are completely different spectrums. To compare what Upol does, what ConAd does, what COSCO does, they are completely different things, completely different projects, different areas so I think they are all the best in their area absolutely. But I think its kind of hard to compare them on the exact same spectrum.
- **Keupen** What are your plans to hold yourself accountable to those promises?
 - o Robinson- One thing that I would like to do, and of course, I said I got this. I will send this as soon as we're done with questions. I have about a four-page sheet that outlines dates that I'd like to have things implemented, I have the descriptions for all of these, and then for two trackers to bill tracker, the bill docket, and you said we did tracker, I have examples of Google sheets of what those would look like, how those would be implemented. Those are ready to go. For the most part without any major refinements over the summer, I check dates for those which I think August 25th, which is our first day of classes. Those two things are pretty straightforward things that we put out there. so giving you access to those is one way that you guys can look at this and say, you said you would do this, and these are the specific details. Why didn't you do this? Why didn't you act on this? And giving you dates also allows you to hold me accountable on bit more of the chronological scale, and then at the same time implementing and I think this is in my platform, bringing back general

- discussion, this is something that used to be on the agenda. I think bringing that back as an opportunity for you guys to hold me accountable in front of the body, on the record in front of OU. This isn't something that I'm talking about where we all sit around and discuss our projects, you are all more than welcome to do that, but this is something that I want to provide to you guys as an opportunity to publicly hold me accountable, because you can take me to a corner and you can ask me hey, how do you planning on doing this? And not, of course, not saying I would, but the opportunity is there for someone to say, I never said that. So, if you have this in a general discussion and you say, you know, how's your platform going? I see you haven't accomplished this yet, but you have a date set for it. Why not? Is there something that's causing that to be pushed back? That just gives you opportunity to hold me accountable on the record so that I can't ever go back on that. It's right there before the entire body.
- **Schonfield** I think as far as accountability goes with regard to my platform and everything. So the first thing that I plan on doing after the meeting concludes, should I be elected, is creating a feedback form similar to what Aaron has on his window. Essentially, I want to make it so that anyone in the body, anyone passing by in the Conoco, can scan that QR code and give me immediate feedback that goes straight to my phone and my device, et cetera, telling me what they don't or do like, generally just having the ability to have a direct line to me and like access to me, regardless of whether or not they're comfortable having that one another conversation or having that discussion generally. I think that's a really important thing. That's a resource that I implemented day one, whenever I was selected speaker for OIL, and I will admit I didn't get a lot of engagement with it, but it is still a very important resource, and I think I can see a lot more from this body seeing as we're actually in session throughout the year, throughout the semester. Actually, you guys might really have feedback for me in the in every in between every week and over the summer, et cetera. Additionally, I want to implement a mid-semester review for example. So that means me, the rest of big three, as well as the committee Chairs, will have the opportunity to give feedback on both my performance, their performance, everyone in the team, an anonymous peer review process where essentially they would fill out a form saying, you know, what they like about, like what I'm doing, what they don't like about, what I'm doing, what I can do to fix whatever I'm doing. that would be a great opportunity for them to bring that up, and that would be the same would go for the vice chair and the secretary, making sure that everyone is held accountable, not just myself. And additionally, I want to make sure that I'm sticking around after every Congress meeting, like I said earlier, and I want to make sure that if someone does have a complaint about me the way I've been conducting myself or the way I haven't been conducting myself, they can address that to me immediately after the meeting or in my office hours.
- Harris- In your opinion what is the purpose of Congress?
 - O Schonfield- So, I think the purpose of Congress is to represent our student body. I think there's a lot of things that we do, we have the ability to do, that the administration doesn't have the ability to do, that other RSO's don't have ability to do. We are elected representatives of the student body who are meant to be their voices. So, I think it's very important that we do everything here as intentionally as possible, and that we are providing real service to the student body. I want to make

- sure that we're getting as much information from them and interacting with them as much as possible, so that we're representing them the best that we can. In that vein, I also think it's important that we make these meetings as efficient as possible and we do everything that we can without using our or anyone else's time, and that's a big part of why I want to focus on streamlining, which is my last point, just making sure that these meetings and every other part of Congress goes well. So, I think really I want to move back. It's the point of Congress is to represent the student body, represent their interests, both to the administration and abroad. So that's what I would say Congress represents.
- **Robinson** Yeah, so I completely agree with that statement. I think I put this in my very first committee presentation for Orientation when I first took over as Upol Chair. We as the body are essentially microphones for everybody else. What I kind of compared it to is when you look at many students, it's kind of like they have a microphone, but it's unplugged. They're talking into it, but they don't feel like they're being heard. And so it's our job to kind of walk up and say this is plugged in I promise, to listen to what they're saying and then take that and translate it into action, translate it into change just as I mentioned in my speech. It's important for us to sit down and listen, whether it's through surveys or interpersonal interactions one on one with tabling with townhalls. It is important with things like that that we get feedback and we use that to amplify it to administrators, like Jacob mentioned. It's important for us to sit here and recognize that we are a body, but again, we are only one of four branches in SGA. We have to work with the executive branch with the judicial branch, with the programming branch because we are just 25% of this entire organization. So working alongside those branches and working with students to get them to recognize that this bond is open. They're welcome to come in, and they're welcome to voice their concerns. And so that's something that I think is incredibly important. I think that's really embodies what we are, is we are a one large microphone for the entire student body.
- Radzanowski- What is one area that you feel you struggle in leadership and how do you plan to improve upon that as Chair?
 - **Robinson** I think one area that I have struggled with in the past initially was and this is something I'm still working on, and this is that's that kind of interpersonal relationship with my committee members. So when I first took over as you Upol chair, I kind of came in as like a coach, but not like a super friendly coach it was more of like I want to get meetings done, I want us to see legislation, I want to get projects over with, and there is no time for any sort of discussion within these committee meetings. That's something that I've been trying to work on a lot more, and I think my committee and I want to think them and take this opportunity to thank them has grown in a bit more kind of like the WAMily. I love that name. I think that's something that we have really focused on and that's something that I've been trying to work on, but it's something I definitely have room to continue addressing this ability to recognize that I am both a coach and a mentor and a friend to these people. I'm not just someone who needs to show up and say this meeting needs to be done in you know 45 minutes because we've gotten a point where Upol meetings and granted, this is not something I'm going to do for general body. These meetings are pushing an hour and a half now, but this is because we have developed and we have pushed for so much communication on our projects, and that's

- something that I think I could definitely continue working on, is this sort of getting down to nitty gritty of like, who everybody is and getting these friendships rather than just some sort of an acquaintance level relationship with everybody.
- on. I think I would have to say I am going to be honest with you I had an answer in my head and then I was listening so intently to what he was saying that I totally forgot what I was thinking. I would have to say as far as things that I may have struggled with in the past with regard to leadership. I can be a stubborn person at times and it used to be very difficult for me to listen to other people's opinions especially when they were off of the plan. This is something that I would like to think I have grown out of. I make a lot of effort to listen to other people's opinions and give them the real time of day and actually improve those things when I can. I would like to think that there are at least a few of you in the body who can attest to the fact that I have came over this hump and come to realize the value of other people's input because that is something that I am actively wanting to run on and make sure that you all know it's very important to me that I get your input and that you have a voice and not just Congress, but SGA as a whole. So that's I guess that's what I have to say.
- **Toyos** If you don't win this position would you still implement your platform and how would you go about it in a smaller role?
 - Schonfield- I think as far as how I would go about implementing my platform, should I be in a smaller role. I would definitely still want to make all the improvements that are in my platform, something that, like Caleb has the ability to do in his administration because regardless of whether or not I'm the person making these changes, these are changes that I think are very important and that we should be leaning into more. As far as how I would hope that to happen, I guess I would just make myself as available to him as I've made myself to Hope as the WAM Chair. Regardless of whether or not I'm the next WAM chair, and just making sure that he knows he has me as a resource.
 - **Robinson** So that's kind of in a similar vein. I think sitting down immediately after this, because it's either me or you. So, if I'm not elected into this position, sitting down with Jacob offering to have a meeting and kind of run through some of the background on my points saying this is exactly why I was kind of going for this, this is what I hope to achieve in implementing this, would you be willing to do this, because our platforms are very similar. We want to accomplish the same goals, although we may have similar projects and the things that we want to implement to get there, we're all walking the same path, to get to the same goals. So having a sit down meeting with him saying, this is what I want to do, this is why I wanted to do it, would you be willing? I don't think it clashes too much with what you're doing and like you said, sitting down and being available. I'm always around he's got my phone number, so always shoot me a text if there's anything, hey, we're still having an issue this, would you be open to allowing me to implement this? I have no problem with that. And I'm going to say now this is probably one of my biggest regrets, not having a sit down meeting with Hope right after last year's election is sitting down and saying this was my platform, of course she saw it, but I don't think she got the whole background on why I wanted to implement it, and I never openly made that available

- to her to say, I really want you to implement these, would you be willing to? And should I lose this election that's something I'd be willing to do.
- Oler-Would you each explain the differences in your platform, the major points, where you see that there is not that same kind of overlap and maybe the difference is in how you would implement your platform since they are so similar?
 - o Robinson- I think one of the biggest things that we kind of differentiate on is the routes in which we would make the body a bit more effective to make these meetings go quicker. He puts a lot of emphasis on the use of parliamentary procedure, and that's to be expected from the former Speaker of the House in OIL, right. But I think that's one place where we differentiate that is something that I just personally have a little bit of concern about. I didn't want to touch too big on. I mean, I talked to people about this in personal meetings that I would like to jump into some semi-specific member things of parliamentary procedure, maybe working with Vice Chair, whoever that will be, to implement some sort of deeper understanding of what parliamentary procedure we pretty regularly use so that they can learn how to use it, how we use it, there's a difference in those two.. So, looking at that, I think there's a different route which we'd like to go. Again, I think we overlap in that. I think there could be a bit more knowledge of parliamentary procedure. I think that the difference may be in how specific and how we get there. Beyond that, I think implementing our platforms, I really can't see if there's any way that be too different. And we're going to sit down and I again, won't speak for you about the opportunity, but meeting with all of you guys who are in these roles, sitting down, saying what kind of changes would you like to see? How do you think I would like to implement this? Because you guys are on an executive committee just because your chair doesn't mean you're not just chairing the body, you're also chairing executive committee and so sitting down with all the committee chairs and saying, how would you implement this? How would you go about this? Because I want to give you guys that voice to.
 - O Schonfield- Cheers to that. I think I'll agree with him. I think a big part of like where we disagree in regards to making things a bit more effective and more efficient during Congress is parliamentary procedure. I have a lot of experience with parliamentary procedure as the Speaker of the House in the previous year for Oklahoma Intercollegiate Legislature. So, I've had a lot of experience working on teaching other people how to do parliamentary procedure and you know making sure that they have easy access to both guides and other resources that make it extremely easy for them to both understand what they're doing and how to do it in a way that's effective and keeps the body moving. I something I will actually steal from you is that there is a way to there's a way to use parliamentary procedure but not use parliamentary procedure and I think that some of the like one that's now there are a lot of other lessons I think people learn from OIL, but that is one of my favorite things is getting to teach people how to use it effectively to both make sure that things are moving along quickly while not skipping over anything important or silencing anyone's voices. And like I said, I have a lot of experience with that, and that's something that I would really like to bring more of to Congress. Not because parliamentary procedure is like this scary thing that any of any of us need to be worried about. It's because it's something that is a tool that is meant to make parliamentary bodies such as ourselves a legislative body, move along quickly and

- effectively. So, I just want to make sure that we're using that to the best of our abilities so that, you know, everything runs smoothly and effectively.
- **Fisher** What would you say is the most significant thing that you have done for the student body?
 - O Schonfield- So as far as the most significant thing that I've done for the student body, I would say our workshops that we created this semester, this year. I had over 50 people who came to the one budgetary process workshop that we hosted. I got a lot of positive feedback. We already know a lot of ways that we want to improve that, and I've gotten a lot, there were a lot better requests in primary this year than we saw even just last year, just from that one experience. So, I want to do more things like that focus on giving everyone in in the student body, not just, you know, members of the Congress, the opportunity to learn about SGA and how we operate, and what we do for them. That's just one example of something that I've gotten to do this year that made that impact. There were also changes to the like, I really was proud of the bills that I got to pass last week through Congress and then hopefully we'll pass GSS this week, that improved the process a little bit for us and students in the body.
 - **Robinson** Yeah, so, although it may seem a little dull at first, I think one of the most important things that I was able to accomplish for the student body was modifying the final schedule in the view that you see on one. So, I was contacted by an advisor who had been asking administration to make these changes for five years. She had been begging, email after email after email to make these changes for five years, nothing was done. She reported to me and I talked to another advisor who confirmed, they're getting hundreds of emails from freshmen who are coming in, they don't know when their finals are, they see this big block of, oh, why do I have an 8 AM? I don't actually have a class scheduled then do I? And then they show up and there's nothing there. Because there's a misconception as to when their finals are. So they're looking at these and they were completely lost. And so I was contacted, I met with the registrar at the time that was Casey, I think. and I met with her and this is actually how I got my student job now, and we talked with Aaron Biggs, Vice President for academic technology or Vice Provost. We made these changes, they were implemented almost immediately, and now regularly the registrar's office every time your enrollment cycle opens, she sends out a PDF outlining exactly how to view One and how to view banner. So all of this has been changed, and then on top of that, although it's not specifically for my role right now, last fall, I had to take over the redistricting for ConAd, and this is something that I did when I was Vice Chair of ConAd as well, which is why they came to me. And that's why many of the changes you see now, we no longer have social sciences, we have Arts and Sciences, many of you saw that. And then I think that another thing, although it may be slightly tangential, this is something that now students seem to have more representation. I think that in conjunction with of course Congress's recruitment efforts has made a lot of difference for the body and the student body as well helping improve that representation.
- Vedra- How have you designed your schedules for next year to allow for these office hours?
 - O Robinson- Next year schedules is pretty easy, I have my honor's thesis, that's not something I have to meet regularly for and then I have an online class, and I believe I have two more classes, one of which is online, so I have I believe one or two. No, I

- have two in person classes. Both of those are Monday Wednesday, Fridays, so my Tuesday, Thursdays are entirely open, and that also leaves me with a pretty significant chunk I think, up until noon on Monday, Wednesday, Friday, to fill these office hours. So my schedule is pretty well designed to hold office hours on either Tuesday, Thursday or to spread them out pretty evenly throughout the rest of the week
- Schonfield- Having been WAM chair this year. I am already pretty used to working my schedule around office hours. I will say that it is a lot easier to make a schedule whenever you are not having to deal with ROTC and the classes and waking up at 5am on Monday, Wednesday, Friday for PT, but I have two online courses, two Tuesday Thursday classes and then I have to take Latin every day but it shouldn't be a difficult process to make sure that there is time in the morning and the afternoon and pretty much every day. I do want to leave my Fridays without an office hour because who wouldn't.
- **Hallum** How do you plan on increasing SGA recruitment in the less active colleges like education or architecture?
 - O Schonfield- So something that has been pitched to me previously was making sure that whenever we are tabling, we are doing that outside of colleges where we have had less engagement. I also have connections with education majors, and I know one or two architectural majors that haven't personally expressed interest, but have talked to other people about possible joining Congress in the future and you know fostering those relationships and making sure to make connections even with the individuals that I know or that they know don't immediately join Congress. Just getting the word spread in those colleges not just you know architecture and education but you know every college that may not have representatives is something that is very important to me and I want to do everything that I can to implement changes that could bring more people in and if anything that I didn't mention is something that you think would be a good idea I am more than happy spending my time implementing anything that you think is going to bring more people to represent the unrepresented in our student body.
 - **Robinson** One of the biggest things that I think I would like to focus on is targeting the underrepresented districts, like you mentioned architecture, and we've recently just gotten academic affairs but academic affairs pre-health two-year, architecture, education, things like that, architecture is a two-seat district, education is one seat district. These aren't hard to fill. If we can find one person in one class who's willing to run for that seat, that's a representative. So, in the past, what we've done is we've addressed gen ed classes, I would like us to kind of shift those addresses specific to classes two classes within these colleges. So what I've done, and I've been recently looking at some of the degree sheets, most we do have looked at those when you're scheduling your own classes. I think my second wife, I was supposed to be an advisor, because I love looking at. So, I've been looking at degree sheets within four majors within these colleges to see which are the most prevalent classes. So what do architecture majors, people within the architecture college have to take the most and then part of those classes go to class now, find the largest sections of those classes and go address those, instead of focusing on gen eds, and then second looking at coming in orientation and you have freshmen who come in, having a survey that's kind of like whenever you visit a website, how did you hear

about this? Having something like that, that outline like, what was it, was it word of mouth, was it tabling, was it town halls, was it us coming in your class and addressing it? What brought you into the body so that we can better tailor our recruitment efforts come next cycle? Because if we're doing things that aren't working, then we need to stop doing those and we need to shift. So having some sort of survey like that that allows us to kind of quantitatively gauge the differences in why people came into the body so that we can consider those efforts, as well as a recruitment and retention task force. This would be composed of one member from every district, plus an associate who I would be able to get feedback from so that I can kind of tailor those strategies, because I as political science major will not ever attempt to say, this is what's going to get a chemical engineer to want to join. I would never be able to tell you. So, having somebody in this formal session where we can all sit together and they can say, I think this would work for me, I'm in these classes, I think this is what brought me in, so can we try implementing that within the college more broadly? I think getting that feedback so that we're able to tailor these approaches is most important thing because there's not one size fits all solution to recruitment.

- **Cunningham** How is your attendance been in both in general body meetings and executive committee meetings?
 - o Robinson- Over this past session, I think I might have missed one meeting I believe early, but I was here for the first half of it. I will address, many of you probably know, I wasn't here for much of last session and that may come up. I was in a field methodologist classes taught once every two years during in general elections and midterms. So I was not here at all last session, and I would briefly come in during meetings, but this was a one day a week class from 5 to 7:45. So this was not something that I could pass up for my future, I would like to focus on field work within the political sphere, and this is something I'm pretty interested in trying to do serving and things like that. So this is not something that I was able to pass up at that time. So this session has been great last session of course, due to academic obligations. I was not able to do that. And my committee they have probably heard this a million times, we're student leaders in that order, so if any of one have other classes around that time, I would expect you to put those first before coming to Congress, because especially if its something like that that's so important to you, jump on that opportunity when you can.
 - o Schonfield- Yeah, so with regard to attendance, I will admit I don't have a great memory, so I'm not going to try to tell you an exact percentage or number of meetings or anything to that effect, but it is my understanding that I've been to pretty much every general body. I will admit that I did have a few a few commitments primarily with ROTC last semester, that I think I did miss one or two general body meetings for, but there were also a lot of executive committee meetings that I had to this primarily for the National Guard and for ROTC again. But with regard to like, any issues that might cause next upcoming year should I be elected Chair I think you being in general, I mean this is absolutely, like, very, very, very important, and I would make this probably my number one priority as far as what I'm going to do with my Tuesday evenings. As far as missing executive committee meetings, if there's something important that I need to be there for, I'll make sure that I move things around or even move the executive committee so that I can be at

that meeting, but otherwise, usually exec is not considering terribly urgent things that whoever the next vice Chair is couldn't Chair executive should I have to be a drill.

On a motion to extend time for questions by 15 minutes Morgan seconded by Vedra

- **Kathuria** Alongside working on improving to Congress, what's a specific university policy or set of issues you would like to address when you are congress chair?
 - **Schonfield** Something that is particularly of interest to need is um a student activity fee that every single undergrad, graduate, and law student pays here at the University of Oklahoma. I don't know, if you guys are aware, but you pay \$5.60 for every credit hour that you are enrolled in that goes to student activity fee. This breaks down a lot to where, you know, it goes to a number of different things that SGA is, I think like, I want to say 30 or 40 cents of that for every time that you're paying that. So, something that I think is very important is making sure that all, you know, related parties are part of the discussion that allocates those funds and something that I would like to see and like to make sure is that the SGA Budgetary Chair has a seat at the table whenever it comes to the student activity fee allocation committee. Right now, it's not something that they are, you know, I don't want them to be a voting member to be clear. I just want them to be in the room because it's important that someone who is so directly engaged in the funding process actually is a part of that discussion because right now, it's only the heads of these different branches that almost all have had no interaction with the funding process at any stage. So, as something that's close to my heart, is money and making sure that you guys' money goes where it gets you. So that's we're probably going to be my number one thing. But again, I would take any important things that any members in the body have and make sure to project our end of our fellow interest, fellow students interests to administration.
 - Robinson- So thank you as the University Policy Chair, I love this question. To kind of take some hints from what we've been working on the committee, I think one of my favorite things that we've been working on right now, that I think will end up being a bit more a long term project is the meal swipes project. I would like to address the cost of meal swipes and what we're getting in return. Some of the research that my vice chair has done on this shows that we are near the bottom in SEC schools, and how much we're paying, so we're paying significantly more than peer SEC schools. We're getting significantly less in return than peer SEC schools. They offer significantly more franchises, significantly more dining hall options. some of them, I believe it is Auburn, I could be incorrect, offer the ability to go off of campus and use your meal swipes or your points at some franchises near campus. So if we could look at doing something like that, this is something that of course UPOL is already working on, but I think using this position to kind of hyper speed that, if it's something that we can bring up in Big Exec whenever they're having those conversations. It's something that I think is really important to me, especially after the last Board of Regents meeting, where they actually just increased the prices of our meal plans, and we expect that peer SEC schools will likely do the same, so it's not something that we're really going to fall behind on because they're going to continue raising these prices for meal plans. Thankfully, the Oklahoma State legislature is passing a piece of legislation I believe has already passed to no longer require freshmen to have meal plans when they come to college. This is something at higher ed day they spoke with Speaker Hilbert about and this is something he's very

proud of, and it's something that whenever he asked me, he said, what's going to this legislation that following, that was exactly what it was, because that's something that I think is important both to me and to me and you, specifically. And so that's something I would like to really continue focusing on, especially as inflation increases and what we're getting in return increases.

- Hallum- Why would you vote for your opponent?
 - **Robinson** Yeah, is my favorite question they ask every single election I love this question. Jacob is an excellent member of the body. He's an excellent WAM chair, absolutely phenomenal. Anytime I walk into the Conoco, he's either doing that or he's playing CP3. I can't hate he is playing computer games, but Jacob is an excellent person. He's incredibly friendly. This is kind of the same thing that I focus on, like, Hope and Jacob in my eyes are very similar and how welcoming they are. I when I first came to the body was kind of like super reclusive and I like, I don't really what to do it and Jacob pushed back and said, I think one of the first light walks I went on, it was Jacob and I, and we were walking down the South Oval, and this is kind of one of this same instances where I finally felt like I was welcome, I found someone who kind of matched my interests, I think at the time you were talking about being a constitutional studies major we were talking about Con studies and that's something that really keeps my interest in this is I felt welcome. I felt like I had a friend. I felt like I had someone kind of valued my presence even if it was because it felt like it was more than just an acquaintance level type thing as I had kind of often experienced outside of Hope in our first general body meeting and we first joined the body. In those meetings it was kind of like I don't really know who to talk to there were people that were kind of scary and Jacob just kind broke that open I think at that time considering we were both new it was pretty easy for him to do, but it was just like scary to me. And so I absolutely would implore you if that's something that's heavy on you, if that's something that's really important and that's something you put forth, and that's something I kind of reflected on in the past few months.
 - O Schonfield- Yeah, I mean hard follow up to such a good answer to the question. But I think if I were to vote for Caleb, I absolutely I think Caleb is one of the most dedicated members in the body that I've seen I mean, Caleb ran for chair last year, he puts a lot of work into his position as you Upol chair, and you can really see the difference between what Upol used to be and something that a lot of you may not know is that the first committee I was ever part of here in Congress was Upol. I hated it. It was awful. Super glad that I changed WAM. Wamily, the point being, I think Upol has come a very long way, and I think a lot of that is owed to Caleb, and the dedication and the care that he puts into everything that he does with his committee. And really, I just I just think he will probably do the same thing if he gets elected chair.
- **Kathuria** How do you plan on trying to sweeten it up and making sure that you know, the executive branch and Congress are working in cohesion together and serving the interests of the student body?
 - Schonfield- I think something that's very important is just making sure that everyone across every branch is on the same page, and there's a lot of intercommunication between branches. I consider myself a friend to both the chief of staff and the president in the executive branch and maybe the same could be said about the VP one day, I don't know, but I feel very confident that regardless of

- whether it's me, that's chairing or Caleb, I think either way there's going to be plenty of open lines of communication between us and the Executive branch.
- Robinson- Yeah, to kind of add to that. I agree. In the same vein, I think the chief of staff and I are pretty good friends. The president and I, of course, becoming relatively new to one another, now that she's assumed this role, but we've had a good communication, and I think this is something that we all need to focus on. They have Big Exec meetings pretty regularly. I think there is an opportunity where we share the same office space the first floor of the Conoco, using that, keeping my door open, we're always open to talk. I think the, I won't speak on behalf of the president, but I think a lot of us recognize that the executive branch is going to have to put their best foot forward, like there's been a lot of precedent set to where there is probably a bit more at stake, and I think they recognize that, and so I think this is something that both us are willing to do, because one it's not something I ever want to have to do as Chair. I don't want to have to do what Hope has done, because that's just a lot of stress, and I think it is a lot of work. It's not something that we ever want to do. That's not the first focus, so I think putting my best foot forward, and I can go ahead and spin my hand here and assume that the executive branch will continue, put their best foot forward into it. And so having these sit downs, and like I said, bringing back the town halls. I think both of us sitting together or anybody from the executive branch, for that matter doesn't have to the president, Chief of Staff literally, anybody in the branch sitting down and hearing the same concerns at the same time with students being able to address them as a team rather than as this branch and this branch, but as one or equal, because we are all equal branches. So addressing those as co-equal branches, when people bring those concerns to us rather than independently saying the executive branch is working on this, we as Congress are working on this, I think doing those together is going to bring us a lot more growth.

- o Aaron Gilson-Bond Nomination and Speech 2:00 for nominator speech
 - Nominator Cade Walker- Good evening, everyone. It's my pleasure to speak to you guys tonight in support of Aaron Gilson-Bond as he seeks to continue his service as Vice Chair during our 114th session of Congress. For nearly three years, Aaron has been a constant, reassuring presence in this body, a steady hand, a thoughtful leader, and someone whose commitment to service speaks louder than any previous title. Gilson-Bond- Howdy y'all my name is Aaron Gilson-Bond. I am currently the Vice Chair of Congress. This is my platform its about what now we can do I together essentially, but next. So I have three points I want to talk about. It's going to be continuation, accountability, and next steps. I sent out to quite a few of y'all, why this is important specifically, but I didn't go into how how exactly I want to go about that, because I wanted to show this with you today, so we can go through the though process together with that. But first thing continuation, I want to keep maintaining the work that I did through my FIT platform. All I points, I did hit in one way or another, I talked about being flexible for everybody with office hours. I very beginning that first week literally the next day, I set my form for you to create my office hours, even if it was inconvenient for me. I said from the very beginning, if you wanted office hours at 6 AM, I was willing to do it. And I know I wake up early quite often. I'm not not accustomed to it. So, I wanted to make sure that I can still be open to you whenever you wanted, but being flexible impactful and showing our internal progress is fundamental to helping the campus experience. I think it is very important for everyone at campus to know what we do here. I think that semester we've done very well, with that, I think the previous election we just had debuted that in a way also, and so I think it's very important. And then I just like I said, although each point has been, hit it is important to keep on going. Next, my favorite point accountability, I think it is very important that we, with our resolutions that we have follow through. Since I've been in the body, often we write resolutions, for a plan, for administration to make, and we often don't follow through, make sure they actually do it. So I wanted to make sure that we can have regular check ins with people who write legislation. So they know it is what they are going to do, whether it's going to talk to administration after showcasing that, hey, the general body of Congress, you know, the student

body believes in this. We have done a lot of surveys this year, I want to take the data we get from those and actually make change at this institution rather than just setting out a survey and then not following through on that. I think it's very important to continue going. As well, follow the standard by holding myself to the same expectations that I set for y'all for myself. I asked to go with letting committee chairs know when I'm not going to be there. Obviously, it's very easy to get an unexcused absence. One thing that I disagree with with the Vice Chair role personally is that whenever you don't show up to meetings, you're automatically excused, I don't think that should be a thing. I think that if I'm not going to reach out to you saying I'm not going to be there, it makes it to where you feel almost forgotten. That was how I felt whenever I was an associate in SUSTY, that was a thing I felt as Chair of SUSTY, when the Vice Chair doesn't show up and there was no notification then I felt forgotten about even when the Vice Chair was literally in my committee. And then yeah, and then just pretty much staying responsive with y'all. I made sure that I responded to emails pretty quickly, For one time, I am going to use Lorelai as an example, she sent me, her bill and she sent it to me super late. I schedule sent it for the next morning, but I saw that immediately. I literally responded when I was bed, just finished a project, was ready to go sleep and I was like, I need do this right now, it is literally legislation. But next one. The next steps, I want to codify the duties in our governing documents to ensure continuity and clarity. I think that progress shouldn't stop with one person. I think for next Vice Chairs, I think it's important to have those duties more outlined inside of our bylaws. I want to make sure that people do go to those meetings with, you know, the committee meetings or making sure they are having Comms meetings things like that, to make sure they're not just not doing their job and getting paid essentially. And then I like I said, prepare future Vice Chairs on necessities of their position. There is a very great like turnover document, but I want to make sure we can iron it out a bit more. There's a lot of things in there that don't really, like matter anymore, as far as how it's in there, it's like really four pages long, and it took me so long to read and I was like, we don't do this, and it's not really necessary anymore. So I want to make sure that we can make sure that document can evolve to help people in the future. I mean, build a relationship between Congress and faculty. I think that I've done that kind of a little bit in one way, but I definitely want to hone on that more. Obviously, we can say that we want to change, but it's up to administration for that actually to happen. I think that if we have a great relationship with them, there would be more open to changing. We've seen that in the past with things that are changed. We can build a rapport with administration to just make them more open to the things we want to do in the first place. • Secretary Harris- What experience do you think makes you best qualified for this role?

So there's lots of different things, specifically in student government I would say Vice Chair of a committee, Chair of a committee, Vice Chair of Congress that would be my experience.
- **Donald** I will be asking you to rank the committees.
 - O Gilson-Bond- I'm not doing that again. Last time that happened it was literally a slaughter you know how it was not the greatest experience in the world, so I will decline to answer that question.
 - Carter- I believe the Code Annotated says that WAM is ranked highest, then ConAd then Upol but to me they all obviously create a huge impact and connect with different areas of campus.
- Hallum- Why would you vote for the other opponent?
 - O Carter- I think the current Vice chair has done a great job with creating a campaign that was relevant to the body when he first ran. He's done a great job of making CSPs he's more of a priority and being more communicative about all that, and being overall more involved. So yeah, I think the next steps for his campaign and the continuation for his campaign is a big factor in terms of that.
 - O Gilson-Bond- I think the biggest thing that would make me vote for Leo is not necessarily her campaign, but it's just how she's in the body in general. As someone who goes to committee meetings, I see how y'all are. I see Leo's dedication to being in the body in general. I think that's definitely a very powerful thing I think there are some members who maybe have fallen out of love over time. There's some that have fall way more into love and Leo is somebody that ever since day one, we have seen her here and she's been dedicated, so I think that's a big contributing factor.
- **Kathuria** Do you believe that the role of Vice Chair should be more defined in the Code Annotated?

- **Granato** When did you guys decide to run for Vice Chair like when did it first pop into your head to be running for Vice Chair?
 - O Carter- Yeah I was considering it for a while. I originally decided not to run. Honestly, I didn't want to make any enemies with anyone. I want to be up here feeling confident, and I do feel confident, but I knew that would be a factor. I decided eventually to finalize that decision to run for Congress, the day before, I communicated with some of my committee members and then communicated to more of our members Tuesday. - **Iglehart** How do you tend to balance to the time commitment required of being Vice Chair with your academics and extracurricular activities?
 - O Gilson-Bond- The same way I have. Something that makes it a little bit easier for this semester. I mean, first thing, I go to all committee meetings, I go to my office hours, I go to a million other things it feels like, regularly I'm in the office at like 1 AM.. I've been caught there before putting in the work. But time management wise next semester, I was actually able to make my schedule a little bit more easier for the role, because obviously when I stepped in I already had a schedule set. So I didn't really get to have a little feng sui whenever it came to making my schedule when stepping into the position. So obviously I was planning on running for it, so my schedule last semester was able to open that up. I've also historically taken a lot of credits, taking 17 this semester. I'm taking 17 next semester, I'm taking six the semester after that, I'm excited for that. So, I have plenty of time on my hands to make sure I can get the roles and responsibilities done as well as to incorporate other things if necessary.
 - Carter- Yeah, I really want to expand on the role of Vice Chair as it right now. So I have been taking 24 hours this semester, next semester I'm planning to 17. I also want to prioritize the what I'm involved in on campus, so Congress has already been a responsibility, it'll be my responsibility or like, my number one priority even more than that next semester and so yeah I am confident I will have the time I need to dedicate to Congress and that role.

- **Kathuria** What is a specific university or external policy issue that you want to address alongside the Congress Chair?
 - Carter- Okay, thank you. I think my main thing is increasing Congress's Outreach that something has been communicated by the nominee and current Vice Chair. There has been a little bit more university policy about the way we communicate with the outside body and student government poses us all publicly I would say. So I want to expand on that.
 - O Gilson-Bond- One thing that I really want to hit on the most, and this was kind of said more by Jacob, no shade, but something that I was always found fascinating was the funding behind the student activity fee. It is something that I bought up a few different times. I think that's something that's very important for RSOs and for outreach, which is something that Caleb talked about, is for them to have whatever they need necessary. To make sure the funding that receive is a little bit more transparent, I kind of disagree with the percentage of how much the student activity fee is allocated to RSO's that is something that I want to make sure that we can get more funding so they can have more outreach because something that makes organizations dislike SGA is the leaders of these orgs. They see that they requested a certain amount of funding they see that they only got half of it or less and it makes them absolutely hate us. It is not our fault necessarily, but I think that we can kind of do a little bit more to help them by trying to get them more funding in the first place. I know WAM loved that answer.
- **Granato** What is one thing that you want to implement for meeting with other Vice Chairs?
 - o Gilson-Bond- So the thing that I did the worst with meeting with Vice Chairs and everybody Vice Chair in this room can attest to this is I send an email and say let me know you have a time to meet. I need to just figure out a When2Meet or something because it has been conflicting with, it makes me so confused. I'm like sitting there trying to send this email but I just refuse to make a When2meet or like a SignUp Genuis because I have heard so many bad things about it and then I'm like you know what I am going to do this but it just does not work. So I am going to try and get a form whenever it comes to meeting with them. Something that I did differently when it comes to the first meeting I had to the second meeting was actually let people know these are the points that I do want to hit. So it lets them know what I can be thinking about before I show up and it's just a weird conversation. I want them to be productive, me and Owen have a habit about just talking about food for instance. He knows what I like I guess, but I think that is a big thing being able to make sure that they can come prepared to know what they actually talk about
 - O Carter- Yeah I really want to listen. I feel that Vice Chairs have a unique perspective about committee meetings, but they still play one of the most important parts in managing the meeting so I just want to be able to listen to them whenever there need to know perspective what can I do to help them. What do they feel like they are missing for their committee and just being there as a support system for them. It can be really hard to be a Vice Chair depending on your strength side and I know I can attest to that, but to all of you thank you for taking on that position and making Congress what it because just because you don't get on stage and share a committee report doesn't mean that your role in the body isn't incredibly valuable.
- **Cunningham** Is there a time that you have had to deal with conflict or adversity in Congress? How did you overcome it and how will you do so in the future?

- O Carter- Absolutely. I know that session 113 has been a crazy semester for all of us. I think you just have to attack everything with understanding, knowing that just because we disagree with people, and knowing that they see things doesn't have to be the end of the world, we can still come to a consensus and support one another because if we support one another, I mean, in our united as a body, that's when we can create change. If we are meeting with each other with constant conflict you just can't create the change we want to, because we can't work together as a team. Congress has grown so much over the past couple years, I know so many different ideas coming from different places, I love the diversity, but we need to codify a little bit and ensure that we're understanding people where they're coming from, and that they're understanding us from where we are coming from so that we can create the biggest change we hope to have.
- O Gilson-Bond- So I don't want to like, name any names, but this conversation came up recently about people thinking that I dislike, I don't want anyone to think like that is a big conflict thing right there. People being like oh my gosh, Gilson-Bond hates me, I don't hate anybody. I don't have the time for it I just don't to hate anybody. So I think that's a big thing is that conversation that's how you past it, people realizing like, hey, you got a problem, we are adult let's talk. And I think that that conversation completely gets rid of, like 90% of conflicts. Obviously, sometimes there's a little bit more that happens, but I haven't ran into that personally. Everything that I have ever dealt with whenever it comes to someone thinking that I have a certain feeling about each other it always ends in a conversation.

And to build on existing initiatives, I propose on doing coffee one on ones with any member of Congress, and by the way, that coffee will be on me. I believe fostering a joyful environment for secretaries, not on these ensures, good morale, but accuracy in the minutes among the entirety of the body. I also want to extend these relationships to Committee Chairs to allow them to voice their concerns to me in a safe space. Building relationships ensures that someone struggling feels like they have someone to lean on for help and I have every intention to be the rock for our secretaries, committee chairs, and every member of this body. With that, Burnett is BRAT encapsulates what I believe we are as the body deserve and need in a secretary. Someone who's authentic, committed and caring. Thank you all for your time and consideration and I love and appreciate every single one of you the way you have appreciated me.

- Morgan- What do you think the most important quality in a secretary would be?
 - O **Burnett** I believe the most important quality is dedication. I feel like you cannot do this role without being absolutely dedicated to the role. It is a huge time commitment. It takes a lot of effort to encapsulate every single part of this role, and I feel you if you don't have that drive and dedication, you just can't perform to the best of abilities.
 - Wintory- I would say the most important part is understanding your position within the Congress. Look that Big 3 are paid to be here, they are paid by each student to be here. It is your job to do everything as Secretary well. It is to get the minutes out on time. It's too meet with everyone. It is to make sure that there is a good community so I think the most important part of being a secretary is understanding your role and knowing that you are paid and required to do that.
- **Granato** Why would you vote for the other candidate?

- Wintory- So, I think Ava is a really high-quality individual I think that she does a great job as secretary. I meant in no way to attack her in my speech. And I would probably vote for her because she has shown that she has a very strong and committed personality. I know that she would treasure this position and complete it to the best of her ability, no matter what.
- o **Burnett** I would vote for Michael because I feel like he has a really amazing personality. I feel like I can relate to him on that. I love talking with Michael. I think he's a very open person and I think that's something really important to have within these Big 3 positions is somebody that you want to come talk to. Someone you want to be a part of their life and ask you how your day is going and all the things and he does that and I really appreciate that about him
- **Kathuria** How do you making sure that we are reducing the number of expulsion bills which are bring written?
 - Burnett- I think the most important thing when it comes to attendance is not only being flexible but being open minded. I feel like the first step in being able to reach out to somebody and be flexible with them is when they reach out to you. I know that all these expulsion bills have mostly been centered around people just not reaching back out to Chloe and being completely absent and not following thorough with that. What I want to do is I want to try to engage as many people as I possibly can and just be an open door for people. I think that is really important to build those kinds of relationships and I think that in itself will be able to decrease those expulsion bills.
 - O Wintory- That's actually a big part of my platform. I think a shared attendance document like I mentioned would be a really great way for people to keep track of their attendance to avoid expulsion. However, I think another major factor in that is making people want to come to Congress. I think continuing to build upon what the previous Big 3 have done of making this a true community and including as many people in that as possible, I think that we can avoid absences and expulsions because people just want to come, they want to see their friends, they want to see the people they hang out with and who they work together and contribute to this student body.
- **Toyos** How do you plan to withhold your personal political views as we are a nonpartisan organization?
 - Wintory- I think that we all I tend to do that every day no matter what my position is I think right now when we're in Student Congress, our beliefs don't matter, we're representing the people., so there's just no place for your political beliefs, in the Conoco, outside the Conoco. We have to remember that representatives, associates, officers, we represent the people, and we can't do that if we're focusing on certain issues on either side of the aisle.
 - O **Burnett** I think that is important because we are both polisci majors. I think I've had experience within first year of Congress being able to withhold those political thoughts and whatever I believe. I think just continuing that and trying to be as impartial as we possibly can and is so hard to do that, but it's such an important skill for everybody to have in this body and especially for the big 3. Impartiality is something that we hold very true to us and I think the continuation of that and me recognizing that in myself, recognizing that I have those beliefs, but also at the same time recognizing that, that is a really important part of my job. And it's very internal.

I think that question is very internal and just how you decide to go about that. I would go and go about that by doing internal work.

- **Kathuria** Do you plan on building off the work done by our previous secretary in providing general public access to pieces of legislation that have been signed?
 - O **Burnett** That is a really great question and a really great thing to point out. I think that Chloe has done an amazing job in her role and to continue that and making that stuff extremely available for not only us as a body but everybody on campus is really important that we have that transparency that we feel that we have kind of lost that connection with the student body and SGA given this past semester. I will do everything in my soul to uphold that and I know that is a very big part of the role and I am fully committed to doing that.
 - Wintory- Like Ava mentioned Chloe has really kind of revolutionized the position, and her most important improvement in student Congress is, giving her the access to update the municode where you can view every piece of legislation, how people vote on it and she does that pretty promptly, and I want to continue, that's part of my, you know, preservation platform. Is that I just want to continue what she's doing by making sure that the that we can and that the student body can easily see what we work on and making that accessible to all.
- Bento- During your time in congress please talk about a time that you faced a significant
 challenge or obstacle and what you did best to mitigate this challenge and serve in your
 respect.
 - Wintory- In my first semester I mentioned I worked in Upol, and unfortunately, those of you in UPol, you can relate that the biggest issue is just getting people to care. And working on the meal swipe donation program was a big issue because I would email people and I just wouldn't get anything back. But I think the biggest representation of overcoming that is just keep working the problem. Elias has done a great job in just reaching out in other avenues, going to the students. So the way that this relates to me personally is that I will never get stuck on if one person says no to something, I will never just get stuck on that. I will always look for other avenues. I'll always look to collaborate with other people in accomplishing these goals.
 - Burnett- Twice within my time of being EA secretary, I have to leave unexpectedly for family issues. I have family in Tulsa and we have a lot to stuff go on, but each time I knew I was going to be absent from EA. I have my chair or anybody else available to record that meeting and make sure that was send to me, and I still make sure that I was able to do the minutes on time as accurate as I could from that voice recording. I think that's the main thing that I've been able to do mitigate disruption in my role as EA secretary.

On a motion to extend time for questions by 15 minutes Vedra seconded by Hallum

- Hallum- What was the turnaround time for taking minutes?
 - Burnett- That is a really good question, I know that my turn around time for EA specifically I would usually get it out between Wednesday and Thursday of the week. So we would have meetings on Sunday. There was one time that I had to unfortunately get the minutes out late because of a lot of circumstances that I was surrounded by, but I do recognize that the expectation of this role within Secretary are out that night or the next day and I am completely committed to making sure that you guys are holding me to that standard and I will hold myself to that as well.

- Wintory- So for the committee meetings, we usually meet on Sunday, Chloe and I actually work at the law library the next day and I was able to work on them and finalize them that night and get them to her and then obviously she didn't use those minutes because she was secretary she can use her own minutes. I'm sure hers are far better than mine. But I feel confident in my ability to get them out in the next day just because I've been doing that in for the committee meetings. The general body endings are obviously going to be a little bit more extensive and there will be a learning curve. However, I plan on scheduling having my schedule where, for instance, I have stacked on my class basically on Tuesday, Thursday, so that Wednesday after our general body meetings, I will have the entire day to get them ready to send them out to you guys.
- Chief of Staff Wolthuis- Do you want to do verbatim minutes?
 - Wintory- Part of my platform is actually making sure to keep minutes verbatim especially for general body because the transparency should be one of the biggest focuses of secretary and of the officer position as a whole. The ability for us and the student body to see exactly what we said, when we said it and to be able to read the minutes like they were there is extremely important to me because it just ensures the most transparency and so yeah in answer I would keep them verbatim. I would use a recording system as she does and I tend to get down most of stuff during the meeting so it shouldn't be a problem.
 - O **Burnett-** Yeah, that's a really good thing to bring up. I currently in committee meetings, we generally have a lot more general discussion especially with external affairs because we discuss our projects. Everything above general discussion that you see on the agenda is supposed to be verbatim minutes, and I always record and keep everything on my phone to make sure I don't make any mistakes. I've checked through it multiple times to make sure that those are verbatim and that everything in general discussion has been summarized to the ability where it's very understandable if somebody's reading the minutes. I understand that the current Chair wants to bring back general discussion and I have that experience in making sure that general discussion is summarized in a good enough way to where there is a good enough understanding from somebody on the outside who is reading those minutes.
- Harris- As we have all experienced there has been a drastic rise in artificial intelligence do you plan on implementing any of that new technology to make sure that your minutes are verbatim and out quick?
 - O **Burnett** I believe in my ability of taking verbatim minutes regardless because I have the recording on my phone. I am not a big AI person I don't use AI that much in my work outside and I think its really important that you have a person still there, rechecking them to make sure they are the best quality so I am not going to use AI.
 - Wintory- I completely agree with her. I mean, with the recording all it takes is more time to make sure the minutes are accurate and if they're complete and that's what that's what the job description is, and I see no reason why we need to risk the integrity of our minutes just to make our jobs easier when we knew what we were signing up for.
- **Iglehart** If elected as Secretary would you consider continuing digitizing past legislation of Congress and GSS?
 - Wintory- I mentioned that part about her updating the Municode so the way it works now is she uploads the legislation for the undergraduate student congress and

then the GSS secretary updates the Municode for their legislation so I would continue that process. In terms of my priority the minutes come first because those are important for transparency but also seeing what the bills are and how people votes that is almost as equally important. So I intend on getting those legislations uploaded to the platform I mean easily within the week could be sooner depending on how much we talk.

- Burnett- Yeah I think digitizing bills and minutes is really important and that is now a staple of the secretary role. I want it to be known that I will give every single portion and role that I am expected of the same amount of consideration as I do the minutes, or as I do roll call, or attendance, or expulsion bills I want it to be known that I care about every single role and I want it to be done as the best of its abilities and I'm committed to make sure of that.
- **Schonfield** Would you please rank the committees in order of importance?
 - O **Burnett** Yeah so I will follow the precedent before this and I don't think I am going to do that right now but I love all of you equally and you all do amazing work.
 - Wintory- I am going to echo Caleb's here. Its impossible to rank the committees because they just do different things, if there was overlap to rank them it would just be ineffective but our Congress was set up in a way where each committee fulfills its role and each role is equally important. So I will not be ranking the committees.
- **Fisher** What would you say are your biggest accomplishments that you have done within SGA?
 - Wintory- So my concrete results took place in ConAd. I was unfortunately only able to write one bill. However, ConAd sees a lot of stuff so I think fulfilling m duty as a representative in ConAd and making sure that everything we see here is the best version of it so we don't have to waste times in these meetings updating you know small errors and small inconsistencies. So, while I don't have a lot of concrete legislation to be proud of, I am proud of my upholding the commitment to make sure everything we do here is efficient and well run.
 - O **Burnett** Yeah, as we know in EA, one of our main goals is to accomplish projects, and one of my main reasons why I joined EA was because of Higher Education Day. And as we all know we had a big setback when higher education day was rescheduled due to weather, I think my ability to help out and help the committee bounce back from that has been my biggest accomplishment. It took a lot of work, it took a lot of tears and having to talk to a lot of people when my throat was sore and blah blah blah but at the end of the day, I thought we have a really, really successful Higer education day and just getting students out there to talk to their legislators has been a goal of mine since I was in high school when I tried went to the capitol.
- Vice Chair Gilson-Bond- What is word count?
 - o **Burnett** My word per minute count is averaging 70-80 which I think is pretty good for a person and I have been growing that since I have been EA secretary. I will say that I am doing a shorthand course right now on typing and that can multiply your count by about 5 minutes.
 - Wintory- Over the past couple months when I realized I wanted to run I have been practicing typing tests and I have screenshots on my phone I would be happy to show any of you. Over 100 test I average about 93 words per minute with with a max of 107.
- Cunningham- How do you deal with stress?

- Wintory- So I am a people person so I think the best stress reliever is just being around people that care about you, care about what you are going through and talking with them about it. That's part of the reason why I love going to the Conoco because I have made some great friends there and people the Big 3 are in their offices they always will hear you out and I really want to continue that acting as a stress reliever for anybody. Student government related or academically related
- O **Burnett-** I would like to bounce off of that I love to lean on the people that I have closest to me every time that I am dying of anxiety like I dont know what to do. I always sit down and call my grandma because she always has the best advice and I mean she has been here for a while she has that wisdom. She always has my back and then after that I feel a lot more comfortable and I feel like just doing that itself has helped me in so many different ways to just bounce back.

Authors Explanation:

President Dunlap- Okay, hello everyone. Thank you all for staying so late. I really appreciate it. For an overview of how the application and interview process went, in compliance with the Constitution, there were five days of application of on Engage. We posted it to the OU Daily website, on our Instagram, and I announced it before you all a couple weeks ago when it was open. And from those applications, it was closed after five school days. From those applications, I had the Congress chair, Hope Rhoades, the GSS graduate student senate chair, Jordan Norris, and the campus activities council chair, Kennedy Corbin, review the applications and grade the applications based on a 20- point grading scale on their three essays and their resume. From there, I took the top four applicants after averaging their scores onto the interview route. From there, I was the only one conducting interviews. In a regular vice president race or something of the sort, it's a highly personal role between the two of us, so it would be who works well with me or what exactly I'm looking for. And so, going into the interviews, there were a completely different set of questions, different things I was looking for from the applications and interviews. Applications were more experience-based, more SGA-based. Interviews were more future-focused-based and vision-based. So, Joseph, do you want to introduce yourself?

Harroz- Yeah, my name is Joseph Harroz, if we haven't met. I study finance and economics. I'm a junior, and I look forward to answering your questions.

- Harris- How many total applications were there?
 - o President Dunlap- 9
- **Finley-** I know the nominee was the Secretary of Development, how would you plan to fill that role?
 - O **Dunlap-** So in the Code Annotated, there is no specified need for secretaries, aside from a secretary of inclusivity or student belonging, as we call it. And so outside of that, we would be reworking how the current secretaries work. We have a secretary of strategic initiatives, Mohammed who has done an incredible job as strategic initiatives, who would mostly be taking in a lot of Joseph's role, but also, as the vice president, one of your main jobs is to work with the EOP and encourage the EOP and also run your own task forces. And so Joseph could continue his work through external development as the VP.
- **Granato-** What experience do you have with CLA in the past?
 - O Harroz- So I was not a member of CLA. Neither was Cyrus, the past VP. But I have gotten to meet Alex and Zaber. And we're having lunch next week. And we've been on a text string. And so I've got some experience helping with interviews. I was an IBC CEO. So I did 45 interviews in two days there. And then I also interviewed the new candidate associates in the JC Penney leadership program, along with the director Rhea Clark. And so, yeah, so I have that experience there. It's experience in public speaking and other areas. And I look forward to helping the co-chairs out in whatever ways possible.
- **Kathuria-** Could you please explain why you chose the nominee that you chose, even as there were probably some other individuals who were arguably probably just as qualified as the one you selected?
 - o President Dunlap- Yeah, so the first thing I'll say is a little bit about that last half about qualifications. I think everyone that I interviewed was highly qualified. I mean, you can ask anyone there wasn't a wrong choice based on experience and qualifications. And they all are amazingly smart individuals. And in a big picture view would have excelled in this position. I chose Joseph because of his future focus. I think we can all agree that the past few months, weeks in the executive branch have been a little tough and a little bit and Joseph really stood out to me because he didn't mention any of that. He was so future focused on his vision and his platform point that he brought up that diminishing the past few weeks of the executive branch didn't come up. And that really stuck out too and why I ended up choosing him is I want to move forward. President Strickland was the 59th president. I'm the 60th, it's a different administration. It's a different set of goals. Obviously, the R.E.A.L. platform is still at my forefront. But Carter ran a different administration than I'm going to run. And with everything that happened these last couple of months, we didn't end up like, we're not able to make that happen. And so we're going to move that to fall. It's going to be in the first few weeks of the fall semester. I'm still in contact with Rep Pay. And then we're hoping to look to do a bigger speaker series there after that with someone, another Rep of some sort, maybe a Rep Cole or something like that, if we could handle that. And so, looking to go forward with that. And then in addition to that, I'm looking to aid EOP in whatever way is possible. And however I can help with that. And with CLA, I'm just looking to help you guys as much as much as possible. I know Cyrus kind of rewrote the whole curriculum last year. So I'm looking to take kind of a hands-off approach, but be there when y' all need me.
- **Kathuria-** As you may know, there are a lot of ideas that have been presented by a wide variety of different campaigns. Have you had the chance to study elements of the REAL platform or the BLOOM platform? And the BLOOM platform and the WIN platform from the year 2023?
 - O Harroz- Yeah, so I was able to help a little bit with Caden, Cyrus and the BLOOM. As kind of just someone who's getting messages out to group meetings and getting involved with Caden and Cyrus. They're kind of the people who just introduced me to SGA. And then I was helping Avery and Carter out on their campaign as well. And so I got some experience there.
- **Kathuria-** If you were to somehow have to step in, you know, as the role of president, whether it's temporary or permanent, tell me, what would you do to ensure the student body knows that you are there to serve the interests of the everyday OU student?
 - O Harroz- Yeah, well, I created a mock platform when I was interviewing with President Dunlap, and it was RISE. So it's helping OU students rise above post-graduation. It kind of stems from resumes, interviews, strength in alumni connections, which all lead to enhanced job opportunities out of And I was hoping to do workshops in, like, career readiness centers and with the Career Center to really help people tailor their resumes specifically to their given majors in their colleges. Because you see that in places like Price and Gaylord, but you don't tend to see resume critiques in a lot of these other colleges, which is what people need to get these internships and job opportunities. The issue isn't that people don't have the opportunity and the things to go on the resume, it's that they don't know what to put

and how to style and format their resume. I think that could help a lot. And also doing, like, mock interview workshops.

- Cade Walker- What do you believe are the biggest issues that students face on campus right now, and how do you plan on facing them?
 - O Harroz- Yeah, definitely. Well, that was kind of what my platform was about. It was really based on post- graduation. But a big issue that students are facing, and I see in Greek life, is that Greek life kind of is its own deal. And it's not really with all these other clubs and SGA and things like that. As someone who is kind of on both sides of that aisle, I really think that it would be a good opportunity for people in Greek life to branch out and see what's going on in places like SGA, because while I'm getting involved late as a junior, it's already been so impactful to me, and I hope that others can see this.

- **Kathuria-** Are you aware of the fact that someone could actually flag a prospective candidate during any point of the year? For example, if they are accused of committing a violation.
 - Savage- Yeah, absolutely. Honestly, my job; people, they've had to call me 'Member Savage' for a few weeks. That's not really the case. I've still been handling stuff,

especially with this election. There's a whole lot of things I've been grateful for that, but there have been a couple things here and there, and just having someone there full-time that can say, even if I'm not doing just reports, doing something like that, just like, hey, go this way, maybe don't go that way. Kind of that guiding hand, that reassurance, constantly there in the office, stuff like that. I think that's something helpful.

- Kathuria- What are some changes you would like to see to our SGA election laws?
 - O Savage- We kind of talked about with the ConAd chair. What prefer not to vote actually means and what the rules and procedures are going to be like that moving forward. The actual process isn't really set in stone. Obviously, like, you know, you have to win and stuff like that. And if you don't, it's kind of like those runoff rules and stuff. How to do it, like the actual process isn't really set in stone yet. My job as part of the judicial branch is just kind of to do what you guys decided when you do stuff like that. So I'd love to work with you guys. Like, hey, this is what you need to do with these decisions. So I just have that guideline. In the future, at least, I have that guideline to go off of in those cases.

• CB-113-36 "Spring 2025 Superior Court Appointment Act." (Dunlap/Rhoads/Norris/Grace/Wolthuis) (Rec of No Rec)

Authors Explanation:

President Dunlap- This is the appointment for Superior Court. We had one justice opening this year. We interviewed four applicants again. We had a lot of applicants, but we only took those prospective for law school. What we hope to do with the court is to shift it to more of a graduate situation so students who are on specifically the law school track or currently in law school when they apply. So the way we cut that down is if you were not in law school or attending law school in fall of '25, we did not offer them an interview. We only took those who were going to law school starting in the fall or already in law school for an interview.

Chief of Staff Wolthuis- Just wanted to offer that clarification because we did actually receive quite a few really qualified individuals this year. People really put a lot of effort into their applications. So ultimately, we really want to narrow it down into those who are either actively in law school or going to law school, as Avery mentioned. Former Secretary Harris is fantastic. Her interview was phenomenal. Her application was phenomenal. She's got deep knowledge about the code annotated, the Constitution, our governing docs, and that is really what she wants to see for Superior Court. Rhoads- And something about Chloe is that she does have experience interning in her County clerk's office, and she's been doing that for a couple of summers now, and so she's very familiar with law; recently accepted into OU law. She knows her code probably better than anybody. And so when it came to the decision, it was an easy one for us.

Harris- You know me. I'm sad if you don't know me at this point. But I'm Chloe Harris. I was your former secretary. I am going to OU law, as we said, in the fall. And being part of ConAd has made me very familiar with the code and the bylaws and how to do all those procedures. 5:55 remaining for questions

• Savage- You said you are very familiar with the code. I do remember in the first semester, you actually sent several candidates to me with incorrect information that could have led them to infractions. Have you taken another look at Section 6 about it and kind of, you know, reacquainted yourself with that part of the code and elections?

- O Harris- I have. What I was talking of was a place after a bill that we had just written about elections. That's where I had meant. It was then taken out of context by those people that came to you and asked about those infractions. But now I am way more familiar. I was in Susty before, okay? So now I'm in ConAd. So I do know those a lot better than I did previously.
- **Kathuria-** Is it in your opinion that the superior court should be diverse in terms of undergraduate students, graduate students, and of people of different majors?
 - O Chief of Staff Wolthuis- Yes, absolutely. We do have quite a few undergrads that are on there; hence why there was only one seat opening up this year because a lot of undergrads are still there. We have a pretty healthy mix, I would say, right now with current law students and undergrads. But given the experience that the applicants showed, we decided that those who are in law school or are going to be attending law school in the fall just had bolstering resumes. They just showed a lot of legal experience; able to interpret different codes in that way. So we had decided that with that one open seat, we wanted to give an opportunity to law school students.
- **Kathuria-** In regards to future Superior Court nominees, will you be more willing to to probably appoint an undergraduate to the Superior Court if another seat were to open up, like, let's say next semester?
 - O Chief of Staff Wolthuis- Yes, if someone had applied. It was not an end-all, be-all rule. We had read through every single application, and genuinely, the strongest applications happened to be those that were going to law school or are currently in law school as well. That's another point to add. If there was an undergrad student who had applied and had a super, super detailed application and had tons of experience that we thought were going to be applicable to the Superior Court, we absolutely would have still offered them an interview. It's not an end-all, be-all, just kind of the way that things should have this year.
- Kathuria- After you graduate law school, what type of law do you want to practice?
 - O Harris: I actually want to go into environmental law, and I owe that all to the Susty committee. I have a passion for the environment that I didn't necessarily have before, and also I took an environmental law class in my undergrad, and there's a lot of restoration that happens with, they're called Superfund sites, those are really places with a lot of pollution, and I would really love to help with getting more laws in place to clean up those areas.
- **Vedra-** In your explanation, you said you wanted to focus on law students with the Superior Court. Can you explain kind of what that means going forward in the future?
 - O President Dunlap- Yeah, so I would apologize for my author's opening, and I misspoke a lot in my author's opening. I think looking at applicants and looking at experiences and taking into account what the court, how the court serves, Law experience sticks out more in those applications. Just like if an undergrad has interns like Chloe for a county clerk but isn't law school or is a sophomore in law in undergrad, that court experience sticks out. So, I apologize. I did misspeak. I would say law understanding and law experience in some sense sticks out more.
