Approval of Minutes | March 25, 2025 Officer Reports -

- O Chair's Report: Hello everyone, welcome back to Congress. Thank you for taking the time to come today. Next week, we're going to be doing nominations for our Big three with Congress, so that's for Congress Chair, Congress vice chair and Congress secretary. Everybody running must have a nomination by a representative and it must be seconded by a representative. If you are somebody who is giving a nomination, make sure that you're not losing your representative seat. At our next meeting, we'll probably have our official election results so our new reps will be getting sworn in at that time, so if you're going to be losing your sheet, please don't give a nomination because you won't be a rep anymore and it would be invalid. Just something to think about there and then we also have a very special guest speaker with us today. I'll give a much nicer introduction when we get there but all I ask is when our guest speaker is speaking today, please put away all technology and give your full attention to our guest.
- O Vice Chair's Report: Howdy y'all! I've got a short presentation for you today, mainly because there are a few QR codes I want to share. First up is my Vice Chair Feedback Form. If there's anything you'd like me to work on, or things you think I'm doing well and should keep doing, feel free to drop that in there. Of course, you're always welcome to talk to me

directly too, but this is a low-pressure way to share any constructive feedback you've got. I've also gotten a lot of questions about what exactly a CSP is. So this next slide just gives a quick rundown of that, straight from the bylaws. And finally, the last slide has the link to submit your CSP. It's the same one that's pinned in the GroupMe. Even though our session officially ends on the 22nd, make sure you get yours in to avoid an unexcused absence. That's important, especially if you're thinking about running for a position later, since one of the first questions asked is how many unexcused absences you've had. That's all I got! Thank you!

O Secretary's Report: Hi everyone, I just have a few things that I want to say. First if you are an associate here is the QR code please scan it and fill out the form so that I can mark you as present. Second, if you are considering running for Secretary, please come and see me so that I can discuss the role in depth with you. There is a lot more to the role than just writing minutes and I want to make sure that those who are interested are aware of the responsibilities within the role. While I don't want to discourage anyone from running, I do want those who are planning to run to be aware of what the role entails.

Committee Reports-

- Campus Outreach, Safety, and Concerns: COSCO met officially this past Sunday. We had a pretty chill meeting and just went over some project updates. Last Thursday, I met with Magen Bednar, Head of the Bizzell User Services Team. She gave some insightful updates regarding COSCO's project to expand the hours of the Bizzell Memorial Library. It looks like the library administrators are strongly considering making finals week hours the same as regular hours, but making the library stay open for 24 hours during dead week and the weekend in between dead week and finals week. I was told that the library administrators will be announcing any changes they make in June so I encourage you all to be on the lookout for that. Also, I was told that the northeast part of the Bizzell Memorial Library is expected to get significant renovations in September 2025 to modernize it. At our meeting, we also gave Bill CR-113-06 a recommendation of do pass. Lastly, COSCO will be holding the last light walk of the semester this upcoming Sunday, April 13th. I sent out a sign-up sheet in the GroupMe yesterday, and I NEED you all to sign up if you want to participate. I use the sign-up sheet to create a separate GroupMe for the light walk, and you will not be able to fully participate if you do not sign up since you won't be added to the group where we submit pictures of lights that are out.
- Ocongressional Administration: ConAd met officially this Sunday, and we went over all of our projects, including bad conduct and student conduct. I also would like to thank everyone who showed up for election tabling last week!
- o **External Affairs:** Hi everyone! EA did not meet this past weekend, but we still have a lot of exciting things coming up! Thank you to all who signed up for Higher Education Day! We will be doing that next Tuesday from 8-4 and if you signed up, I will be sending an email out tomorrow with all the details you'll need so please be on the lookout! We also have our upcoming Minimum Wage panel that we are cohosting with econ club! As a reminding that will be on April 25th from 3pm-5pm in the forum room in the Thurman White Forum building so please mark your calendars. We will have Breea Clark moderating the panel and a bunch of great panelists for this debate! Have a great week!
- O **Human Diversity:** Hi, we met unofficially this past Sunday. We are still waiting on one of our projects. The Open discussion forum is looking like it is going to be next semester. They finally reached out to us and said that they are not able to host this semester, but to contact them again in the fall so we will get preparations for that. Not this weekend but last weekend we saw CR-113-05, we gave it a recommendation of do pass and I would also like to note

- that it is two first time authors so shout out to that when we get to that. Other than that have a great rest of your week.
- O Sustainability: Good evening, Susty met officially this past Sunday, and we scheduled our final trash walk, which will take place in partnership with Green Week on April 26th from 12-2pm at the Duck Pond. Although this is after the session ends, I trust that we will still have high participation since all of you volunteer out of the goodness of your own hearts, rather than for a CSP. We also discussed partnerships with environmental orgs throughout Earth month, and we will try to promote those events during announcements and comments. Also, we are seeing some great support for our confetti awareness signs across campus. I encourage all of you to promote these signs on social media, and to encourage your peers to be conscious of their confetti choices. Shoutout to Kayla Hynes for making these signs happen. That's all I have, thank you!
- O University Policy: Hi everyone Upol met officially this weekend. We saw two pieces of legislation. CR-113-07 and CB-113-25 we gave both of those recommendation of do pass. We are only seeing CB-113-25 today, we'll see the resolution next week. We also kind of discussed some of our group outing plans for the OU Texas softball game. I will have some more plans for you guys on that after a bit of consideration. We're going to try and get all of Congress to go, so we're trying to figure out the ticket and logistics for that, but that will be April 27th, I believe, which April 27th or 25th, this Sunday game, that is the third game in the series, so we'd like to try and see if we can get all the Congress to show up for that game and then other than that, I don't know that we have a ton going on. We do have one petition circulating, which, as of last time I checked had over 600 signatures, for changing our current meal swipes programs changing the options we have for housing food services, and then we also currently have our minimum wage survey for students, which will be acting until May 9th.
- O Ways and Means: Last week WAM got a short video made to show students what a WAM meeting looks like, and now we're working on putting finishing touches on a long-form video meant to act as a one-stop-shop for any treasurer hoping to learn about funding, how to apply for it, and how to spend it.

• CR-113-05 "Women's History Month of 2025" (Higareda Castillo/ Mosisa) (Rec of Due Pass)

Author's Explanation:

Higareda Castillo- Hi guys I am Lilly Higareda Castillo.

Mosisa - I am Lilly Mosisa.

Higareda Castillo- And it is a little late but better late than never, a lot of love and research went into it, but first of all I want to ask all of you to think of a woman who has impacted you or your life heavily. It can be a family member, a fellow colleague, or a mentor. Women's contributions are important to our society and in history and with this concurrent resolution we aim to acknowledge the importance of preservation and recognition of Women's History Month.

Mosisa- This resolution is not just about honoring the women who came before us, but about standing with those that continue to fight today. Gender discrimination remains a reality, affecting access to education, economic opportunities, health care research and safety. In the US, women still earn about 83 cents per every dollar that a man earns. Additionally one in three women experience rape or physical or intimate partner violence and 1 in 5 face such violence in college.

Higareda Castillo- As students it is crucial to be aware of these on going issues. We hope this bills inspires more awareness of gender discrimination and women's history, fostering an environment with gender equality can truly strengthen our place.

- **Aslam** Do you think there is a lack of context presented with some of the information represented in these whereas clauses?
 - O **Higareda Castillo** There may be. I was trying to acknowledge the information about the gender gap and payments to make anyone reading the bill aware of the contribution of women in education compared to men and also I use the reference of past resolutions in Women's History and all of them had statistics like this. So I updated them to the ones listed.

• CB-113-23 "Safety of OU Survey Act of 2025". (Keupen) (Rec of Due Pass)

Author's Explanation:

So basically this bill just authorizes a campus wide survey to access how students, faculty and staff, feel like how safe they feel at night and the goal is to collect honest feedback about night time safety, violate awareness and use of current safety resources and identify specific areas for improvement, like lighting, security presence or transportation, and then these responses will be anonymous and the results will help guide future advocacy and policy decisions and just by passing this bill, we're taking a proactive step to ensure a safer campus for everyone.

• CB-113-24 "Session 113 Expulsion Bill No.3) (Harris) (Rec of no Rec)

• CB-113-25 "Conoco Student Leadership Center Pilot Program Extension Act of 2025." (Dunlap/Wolthuis) (Rec of Due Pass)

Author's Explanation:

Chief of Staff Wolthuis- Hello everyone this is Ellie and I'm Avery. We are about to present this. So for those of you that were in the body last year you might remember seeing a very, very similar resolution come through. This year, we are doing a very similar thing. So essentially the way that the Conoco used to be structured is the second and third floor, those spaces were allocated two specific RSO's across campus. Obviously there are not that many offices, so it was only a very, very small handful out of the 550 RSO's on campus that were actually able to use those office spaces. Those were their offices. However, a lot of the offices did not get used. A lot of them were used by their storage offices. No one was ever in them. So the space was kind of gone to waste. Essentially, every year, it was kind of brought into discussion when we had the reallocate these spaces do we consider doing it like this, or we do try to reimagine in this space to turn it into something bigger that can benefit all RSOs? So, last year I believe February, perhaps, when Caden and Cyrus had first started

their administration, they decided let's do something different. Let's restructure this to fit all RSO's and let's turn it into a reservable space, so RSOs can go in, reserve these spaces for meetings, interviews if they need them, whatever those RSOs deems fit for their mission, and they can reserve them. So, we started a pilot program last year. It was supposed to last this entire academic year, however, because of renovations to those spaces, it got very delayed and we only are able to start collecting data this semester. So, this bill is just elongating that pilot program to give us a full academic year to really collect that data.

President Dunlap- Questions that came up in committee were what is the max amount of time students can reserve those spaces? It is four hours per day. How students reserve them, specifically, is through an RSO you have to be registered with an RSO. So if you on the Engage page for that RSO, you can, reserve the room for that RSO use. It's not can I reserve it to study, like the biz or other rooms, maybe in the union. You have to have an RSO and be linked to an RSO on Engage. And again, the max is four hours per day. That can all be done at once or at separate times, so four hours per day. And it is not reoccurring. You can't say 1 o'clock to 5 o'clock every day of the week. You have to register each day for that reservation.

- **Donald** You mentioned that you have not had much time to gather feedback. Have you gathered any preliminarily feedback regarding the use of this and if so what?
 - O Chief of Staff Wolthuis- Yes absolutely so George may be able to answer the what side of that, but Miss Mary that you all know and love in the Conoco, she goes around and does head counts to see how often those spaces are being used, how often we see bodies in those spaces. So that it is something that has been collected. We have only been able to be in this pilot program for about 2 months now I believe. So it is all very early data and we are still waiting to get that feedback to really push it to RSO's.
 - o **President Dunlap** And on the back end of that of the website side of course it shows us what reservations are being shown, so also Miss Mary is counting there is a reservation at 2 pm are students actually in there at 2pm. Otherwise students are free to use office spaces until there is a registration for that room.
- **Fisher** In the case that we say no to this bill, do we know what would happen exactly, like if we say no to this extension?
 - Chief of Staff Wolthuis- We would have to have quite the conversation with Bid Exec and figure it out.
 - President Dunlap- Yes the bill was written to collect data so we could decide whether to go back to the old system or go to what the pilot program is. The new system created through the pilot program.
 - O Chief of Staff Wolthuis- Yes, I would assume that if this were to fail we would have to just put it into law or into our Code Annotated. This is so we can really test and make sure that this system is going to benefit RSOs. If this pilot program were to fail we would not be able to have the pilot program, we would just have to write the new restructuring into our code.
- **Fisher-** I guess for more clarification is this for the sake of extending the program entirely or for the sake of gathering data?
 - O Chief of Staff Wolthuis- Data collection. So right now its pilot program because we are not writing it into our Code. If we wrote it into our code, it would be indefinite. This is a system that we would 100% adopt, we would not rethink anything. This would be the system. It is a pilot program so we can continue to collect that data,

tweak anything if necessary and then next year when this pilot program officially ends, we are able to say ok we think it should be 5 hours instead of 4 hours we are going to write that into the code. We think it should be done this way that is the gist of it if that makes more sense.

- **Kathuria** Would you accept a friendly amendment to add a new section to this bill saying that registered student organizations can only reserve an allocated space for up to 4 hours in a given day?
 - O Chief of Staff Wolthuis- Yeah that's a function, I guess we could, for transparency. Sure.

• CR-113-06 "Scholars Walk Revival Resolution." (Lim/Shibu) (Rec of Due Pass)

Author's Explanation:

Lim- Hello everyone my name is Aaron Lim.

Shibu- My name is Saniya Shibu.

Lim- And we are from the COSCO Committee here to present the bill to revive the Scholar's Walk. So what the heck is Scholar's Walk? If you walk on the east side of the South Oval, you'll notice that on the side with the bikeway, there are these embedded plaques that honor these students that won nationally competitive scholarships.

Shibu- It hasn't been updated since 2019. There's been about 30 plus students from the University of Oklahoma that have received one of these competitive scholarships and there's a lot of empty plaques and these students aren't being acknowledged for their high achievements from receiving these really competitive scholarships.

Lim- And that's why we are here to urge the office of the President to revive the Scholar's Walk project and to honor these students and of course have the current student body to be motivated to pursue these nationally prestigious awards and these scholarships are a really big deal. They represent top one percent of the undergrads in the United States. So, it's a good way to honor them and that's it

- **Fisher** When considering what scholarships to add to the scholarship walk would you add scholarships that are not listed on the bill, for example the Astronaut Scholarship which is considered equally competitive to these others?
 - O Lim-Yes so some of these new scholarships we would work closely with the advisor for these nationally competitive scholarships, who got them in the past, in 2019 to finish putting these names into the plaques. So yes, so anything that comes directly from the Honor's College and outside will be considered.
- **Iglehart** Do we know why the Scholar's Walk hasn't been updated since 2019?
 - O Aslam- So basically the exact reasoning was unclear. The OU President, the new one that we currently have President Harroz, he has not really revived it. He hasn't really given an exact justification, but it essentially is just a recent change and we don't know the exact reasoning why. Which is why we are putting out this bill to hopefully, possibility get some feedback and open dialogue with the people responsible for it.
- Wintory- From what I understand the website that recognizes these scholar's is also not being updated since 2016 is the website included? Do you plan to do a separate resolution or do you have any plan to maybe urge the University to acknowledge these people online?

O Aslam- So if you look at section 3 of this bill it says "The University of Oklahoma Student Government Association encourages the University to update its public-facing scholarship recipient webpage" so that is included in this.

CONGRESSIONAL RESOLUTION CR-113-05 SENATE RESOLUTION NO. GFXX-XX/GSXX-XX

AS INTRODUCED

A Concurrent Resolution acknowledging the importance of the celebration and recognition of Women's History Month; and providing for distribution.

Whereas: In 1987, widespread support from the states led U.S. Congress to declare March as National

Women's History Month in perpetuity (Pub. L. 100-9), issuing a special Presidential

Proclamation yearly¹; and

Whereas: Women's History month highlights the role of past and present women in reforming society

in American history, and a symbol for the continued battle towards gender violence and

equality today2; and

Whereas: Women continue to struggle with institutional discrimination and scarce representation³; and

Whereas: These problems lead to wage gaps between men and women, limited access to education,

gender-based violence, lack of health awareness and research, and other prejudiced issues;

and

Whereas: Women's History Month seeks to commemorate and encourage educational pursuits,

awareness, and celebration surrounding the essential role that women have played in

American history; and

Whereas:	March 8th is annually	recognized as Internationa	al Women's Day,	a globally recognized

holiday that seeks to celebrate women's achievements and take steps toward creating a world

free of gender bias; and

Whereas: Over 1 in 3 women (35.6%) in the US have experienced rape, physical violence, and/or

stalking by an intimate partner in their lifetime4; and

Whereas: One in 5 women are sexually assaulted while in college, with 9 out of 10 victims knowing

their offender previously; and

Whereas: As of the year of 2022, the University of Oklahoma had a total of 44 reported rape offenses

on the university's property⁵; and

Whereas: As of Fall 2023, the University of Oklahoma has a total undergraduate enrollment of 22,046,

with a gender distribution of 48.5% male students and 51.5% female students6; and

Whereas: The University of Oklahoma has a total graduate enrollment of 7,261, with a gender

distribution of 49% male students and 51% female students; and

Whereas: In the 2023 to 2024 school year, women earned about 61% of all degrees and certificates

conferred at public higher education institutions, while men earned 39%7; and

Whereas: As of the year of 2021, Women made up an estimated 44 percent of the overall workforce,

but an estimated 41 percent of managers8; and

Whereas: Overall, women earned about \$.82 for every dollar men earned; Hispanic or Latina women

earned about \$.58 and Black women earned about \$.63 for every dollar White men earned;

and

AS INTRODUCED

A Concurrent Resolution encouraging the revival of the Scholars Walk and providing for distribution.

Whereas: The University of Oklahoma has long prided itself on being a nationally recognized

academic and research institution, producing recipients of competitive and prestigious national scholarships, including but not limited to 130 Fulbright Scholars, 63 Goldwater Recipients, 38 Boren Scholars, 30 Rhodes Scholars, 14 Truman Scholars, 8 Marshall Scholars, 7 Udall Recipients, 1 Gates Cambridge Recipient, and 1 Mitchell Scholar¹⁰; and

Whereas: The Scholars Walk was constructed in the summer of 2014 to honor the names of all OU

undergraduate and graduate students who have won the most prestigious national and international academic scholarships since 1890, with engraved plaques permanently

embedded in the walkway on the east side of the South Oval¹¹; and

Whereas: The Scholars Walk is a prominent stop on campus tours, often highlighted by student guides

as a symbol of OU's academic prestige and commitment to excellence, yet its current outdated state presents an incomplete and misleading image of student achievement to

prospective students and their families; and

Whereas: The South Oval, where the Walk is located, serves as one of the most heavily trafficked and

visible parts of campus - making the Scholars Walk a key opportunity for OU to showcase

its academic legacy to visitors, students, faculty, and alumni alike; and

Whereas: Despite the Walk's visibility, its lack of updates sends an unintended message that recent

academic success is no longer institutionally recognized or celebrated; and

The plaques on the South Oval have not been updated since 2019, despite the fact that there are 44 open spots titled "Scholars Walk" with no names on them, and 37 nationally recognized award recipients since then, including 16 Fulbright Scholars, 9 Goldwater Scholars, 5 Boren Scholars, 2 Truman Scholars, 1 Mitchell Scholar, and 1 Rhodes Scholar; and

Whereas:

The existence of blank, unused plaques creates a dissonance between what is advertised to the public and what has been preserved, weakening trust in the continuity of OU's traditions; and

Whereas:

The University of Oklahoma's website listing recipients of nationally competitive scholarships has not been updated since 2016¹²; and

Whereas:

Recognition of academic achievement should hold equal visibility and institutional value as other high-profile disciplines, including athletics, performing arts, and leadership organizations; and

Whereas:

Honoring student scholars alongside other celebrated groups reinforces a balanced campus culture that values intellectual, creative, and athletic excellence alike; and

Whereas:

Peer institutions such as the University of Minnesota¹³, University of Houston¹⁴, and others maintain academic walks, digital showcases, or engraved monuments to celebrate student excellence, reinforcing their commitment to academic achievement and competitiveness; and

Whereas:

The students honored on the Walk are often those whose academic achievements bring national visibility to OU, through publications, research, fellowships, and leadership, further justifying institutional celebration and archival; and

Whereas:

Reinstating the Walk could strengthen alumni engagement by honoring individuals who go on to represent OU in elite graduate programs, research fellowships, government service, and national leadership roles; and

Whereas:

The President's Office has the institutional authority, visibility, and administrative reach to revive and sustain the Scholars Walk as a long-term program supported by centralized oversight; and

Whereas:

Many students - especially those pursuing competitive scholarships - aspire to earn a place on the Walk as a tangible recognition of academic achievement and use it as a motivator to push themselves toward excellence; and
