# Approval of Minutes | September 2, 2025 Officer Reports -

There is a lot going on, but I encourage you to simply ask 'On information...' if you feel lost or confused. I will do my best to guide you all and explain what we are doing as the meeting goes on. There is likely a returning member around you, so I encourage you to ask them for guidance as well! Orientation this Sunday will dive deeper into the experience, the motions, and the voting process it all comes with time. We will have a presentation from Dr. Deborah Watson, the Director of the OU Testing Center today. I also encourage you all to fill out the Congress Climate Survey to voice your expectations for us all, you will see this at least two more times over the session so that our leadership can be guided by your recommendations. If you have not yet reapplied, I need you to do so as soon as possible.
- Vice Chair's Report: Good evening, everyone. I hope your day has gone well, and I'd like to give a special welcome to our new member. My name is Aaron Gilson-Bond, and I serve as the Vice Chair of Congress. A little about me, I've been part of Congress since my very first semester here at OU. As Vice Chair, my role can be summed up in one word of advice. I advise the Chair on matters related to Congress, I participate in every committee to help

members think through issues, and I work to help new members get oriented and feel at home in this body. Now, I won't keep you too long, so let's move on to business. I truly enjoyed getting to meet you all during interviews, and I'm excited to see the work we'll accomplish together. That's all I have, thank you!

O Secretary's Report: Hey everyone. My name is Michael. I'm a Political Science and International Security Studies major. I play for the OU men's rugby team. I've been a member of student congress since I started here at OU and I serve as secretary now which involves taking minutes for each general body meeting, keeping track of attendance for these meetings and committee meetings, and updating our files and municode with new legislation. When all the secretaries are picked I'll make sure they know how to take minutes for their committee meetings and how to ensure that congress runs smoothly. Also, if you're an associate please scan this to track your attendance.

## Committee Reports-

- Campus Outreach, Safety, and Concerns: COSCO did not meet this week. We are looking forward to starting the semester strong next week with our first meeting and looking forward to meeting the new appointees and welcoming new COSCO members. I also want to communicate our desire to increase our cross-committee collaboration and welcome all members of the body to come to our meetings with any concerns they have. For those that are new, COSCO's primary function is to hear student concerns and address them in the best way possible. We are actually going to be collaborating on a new mission statement this semester, so we will have a better-defined role soon! We have a pretty broad area of what people can work on for projects, so if you want to just generally be a helping hand for your classmates, we might be a really good fit. We also hold light walks on a regular basis, which involves walking around campus and ensuring all the lights are in working order. We are targeting September 21st at 8pm for our first one of the year, but it will be confirmed on Sunday, and information will be sent to the GroupMe. Additionally, apologies to any emails I was late replying to in the COSCO inbox, it wasn't showing up in my outlook for a while. Speaking of committee meetings, COSCO will now be meeting from 5-6pm on the second floor of the Conoco. This is a new time, so please keep that in mind. I want to thank Emma Duncan for her willingness to remain as COSCO secretary. She will be a great help as I start this new role. I am also seeking a new vice chair, and I sent out information about it to my committee in my Sunday email and am hoping to have the position filled by our next meeting.
- O Congressional Administration: Hey everyone, I am Kyle, and what we do in ConAd is look at the interior of SGA and do things such as appointing people to positions, making changes to the code annotated and bylaws, and pretty much anything else that has to deal with legislation. This Sunday, ConAd conducted gen app interviews, and out of 138 applications, we accepted roughly 80 new associates and 10 new representatives.

- O External Affairs: My name is Hope Rhoads, and I am this year's External Affairs Committee Chair. External Affairs has everything to do with the government outside of OU. This means local, state, federal, and tribal governments. Some of our projects include Higher Education Day at the Capitol, which is a day when students from OU go to the State Capitol to lobby for higher education, civic engagement forums where we bring in guest speakers to discuss topics like the minimum wage (shout out Ava), voting registration, bar safety materials in places like Campus Corner, and much much more. This Sunday, we discussed projects like leading presentations to international students on how to get state IDs, bar safety updates, and another Civic Engagement Forum. If you have any questions about anything External Affairs, please don't be afraid to ask!
- O Human Diversity: Hi everyone! My name is Lorelai, I'm the Chair for the Human Diversity committee this session. I'll read our purpose real quick here: The Human Diversity committee shall address any and all issues related to diversity within the University of Oklahoma. The committee shall advocate for policies within the University and within SGA that promote inclusivity and equality. We're a project based committee that focuses on any and all diversity related issues experienced on campus. This week we met unofficially and just discussed some potential projects for the semester.
- O Sustainability: Hello everyone, my name is Owen, I'm a sophomore and I am the Chair of Sustainability this year, we did not meet last Sunday. Susty exists to support environmental initiatives and groups at OU, which means we cover a lot of areas and responsibilities. I'm very excited to work with all of you this year, and will go into more detail this Sunday.
- O University Policy: Hey y'all. My name is Cody Walker. I am a senior studying political science and economics and I will be your guy's UPOL chair for this semester. UPOL is pretty self-explanatory. We work on issues related to University policy. Our responsibilities include gathering student input, drafting policy recommendations or resolutions, and collaborating with administrators and faculty. Some of our main issues that we have been working on are student wages, AI policy, public transportation, meal swipes, test per day limits, TopHat regulations, stuff like that. ## **Author's Explanation:**

**Chair Martin:** We had 138 applications total. Everyone that has been accepted were great in their interviews. It was amazing meeting y'all. We learned so much about y'all and can't wait to meet all again Sunday. Also, we all had bias training.

- **Representative Morgan:** Would you accept a friendly amendment to Section Four inserting the following name and district: Angel Tovilla, Pre-Health Sciences District?
  - Chair Robinson: I would.
- **Representative Vedra:** Can you please explain the process for appointing a representative rather than appointing an associate?
  - O ConAd Chair Martin: So when it comes to appointing some as a representative rather than an associate, you completely pick the person who has the most points. So that comes with your application and your interview. So whoever got the most points were appointed as a representative.
  - O Chair Robinson: The three criteria we grade your applications on are passion, cause, and personality. So these are the three things we look for in your application and then we grade all of those on a scale from one to five, and then each of your questions are graded on a scale from one to five.
- **UPol Chair Walker**: Would you accept a friendly amendment to section three inserting the following names: Rebecca Corbett, Kaden Keller, Jack McCarty, Shield Mulalira, Jackson Ivester, Meagan Edwards. And striking the following names: Zayd Taariq and Adelyn Rasure?
  - o Chair Robinson: I would.
- Representative Hallum: Approximately how many applications did you review?
  - o Chair Martin: 138
- **Representative Vedra:** You said in your original explanation that 138 were reviewed and 80 were accepted. How many did you interview?
  - O Chair Robinson: We interviewed around 100. There were about 30 who had scheduled and didn't appear or just didn't schedule after applications
  - O ConAd Chair Martin: And we're counting both people who showed up in person and people who couldn't make it to their in-person interview.
  - O Chair Robinson: Yes, those people were provided with an alternate set of questions which they sent back to us and we reviewed just as we would in person.

On a motion to recess for 5 minutes Martin seconded by Christiansen

o CB-114-007 "Campaign Period Reduction Act" (Robinson/Savage) (Rec of Due Pass) **Authort's Explanation:** 

Chair Robinson: This is the campaign period reduction act, we talked to alot of our peer SEC schools and realized their campaign periods are significantly shortter than ours. IT just so happens, and correlation is not always causation, but this is just an issue that we've recognized that turnout at OU and for SGA elections happen to be lower. In my assumption, based off these discussions, is that it is because engagement decreases as the campaign period goes on. So after a few weeks, you've already announced your campaign, and everybody is already tuned all the way out because they've seen so many group new messages. They've seen so many Instagram posts, they've gotten a ton of emails. They're kind of just tired of saying it. So we're hoping that by decreasing the campaign period, we can keep engagement up and hopefully increase our turnout a little bit. And there is a second thing all the way down here that we have also decided to change Baylor. Do you want to kind of go into detail about that?

Commissioner Savage: My name is Baylor Savage. I'm the election commissioner. We did some re wording actually. It's not going to change anything in effect. This year, we looked at it, we actually had 10x the number of applicants for the election staff than last year. That's very exciting for us, but we wanted to make sure we had enough room for stuff like that. We were going to change it to increase it to 5 election commission staff members. However, in looking at the financial section that's actually already the case, but the wording in the composition of the Election Comission is actually just wrong, well misleading. So, we just changed that wording to be consistent with the financial section, just ensuring that everyone knows I can add up to 5 members of my election staff. For anyone that doesn't know what that is, those are just people who are going to help me with the elections. They oversee thighs, things that are good but also if any infractions or rule breaks occur, they're the ones who are actually giong to be voting to deicde if that did happen and how many points to decide those cases. Caleb approached me with this to see if it was possible, and I said yes, absolutely. So I'm just here supporting it in all things.

- EA Chair Rhoads: Authors, are you aware that is says 7 instead of 5 SGA members?
  - O Commissioner Savage: Thank you for pointing that out, 5 SGA members make up the commission. This commission includes myself as well as the ex-officio member makes it the full 7. That was the wording that we had issues with. I wasn't actually sure last year. I had 3 Election Commission staff members because of it. This time it very clearly tells you what you can have.
- **COSCO Chair Christiansen:** I noticed how you talk about how signatures can be collected and that there wasn't any time frame for collecting signatures. Was that intentional?
  - **Chair Robinson:** There should have been no changes to the time frame for collecting signatures because we didn't want to establish a time frame.
- **COSCO Chair Christiansen:** What is the current time frame?
  - O Commissioner Savage: Absolutely, so for those who are unaware of that part, signatures are needed to run for either the CAC Chair position or the SGA President and Vice-President ticket together to get those. You can start collecting signature that semester of the running date. So let's say President and Vice-President are

running this semester, they have from now until the finding period which is a hole separate thing I won't throw at you now. Bust basically, they have the whole period starting from the beginning of the semester. I've already been contacted by several teams who are doing that. But you'll notice from this they actually have one more we to do that. We are adding on an extra week. Finding is going to take place a week later, so they'll have more time to collect those signatures.

## AS INTRODUCED

A Congressional Act of Procedure appointing Representatives and Associates in the SGA Undergraduate Student Congress; providing short title; and providing an effective date.

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

**Section 1**: Title: This act shall be known and may be cited as the "Session CXIV General Application Appointment Act."

**Section 2**: Purpose: The purpose of this act shall be to select new Associates and Representatives pursuant to the SGA Congressional Bylaws, Section 3.2.3(a).

CONGRESSIONAL BILL CB-114-007 SENATE BILL NO. GF25-XX

#### AS INTRODUCED

A Congressional Act of Legislation amending the Code Annotated to reduce campaign windows; providing short title; and providing an effective date.

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- **Section 1**: Title: This act shall be known and may be cited as the "Campaign Period Reduction Act."
- **Section 2**: Purpose: The purpose of this act is to reduce the campaign period and reschedule election days.
- Section 3: AMENDATORY: The University of Oklahoma Student Government Association Code Annotated Title VI is amended as follows. For the purposes of this bill, all items removed shall be denoted with a strikethrough. All items added shall be denoted with an underline.

## **Chapter VI-1 General Provisions**

- 1. **Definitions** 
  - 1. **Academic Week** Any week (Monday Friday) during which the University holds classes for at least one (1) day.
  - 2. **Campaign Spending** The value of any products, services, or expenses incurred by the campaign. "Value" should not include any discounts, which are not available to the general public, but should include the value of any services or products donated. This shall not include the value of any non-professional services performed by students.
  - 3. **Campaign Time Frame** The time between the first class day of the <u>ninth (9th)</u> eighth (8th) Academic Week and the validation of the election.
  - 4. **Campaigning** Working in an organized and active way to promote a candidate as a representative of or at the directive of that candidate. Campaigning shall not be

- constructed to include any public campaign materials disseminated during the signature collection period, statements made about one's platform, or any solicitation for votes in the election shall always be considered campaigning.
- 5. **Class Day** The Period of time from 8 AM to 5 PM on a day in which classes are held.
- 6. **Designated Agent** A person chosen and registered by a candidate with the ability to represent the candidate in any official capacity.
- 7. **Election Fraud** Any act or omission completed or attempted with the intent to deprive a candidate or voter of their rights.
- 8. **Information on Candidates Booklet** A booklet published by the Election Commissioner on the first day of the Ninth (9th) Academic Week containing a statement from the Election Commissioner, a list of all candidates, and the pieces of literature from the candidates who submitted them.
- 9. **Eighth (8th)** Ninth (9th) Academic Week The Academic Week in which Candidates may begin campaigning. Campaigning shall only begin at the start of the first Class Day of the given Academic Week. The Academic Week in which the Information on Candidates Booklet shall be published in the given week of the Fall and Spring Semesters.
- 10. Eleventh (11th) Tenth (10th) Academic Week The Academic Week in which Fall and Spring Elections shall occur. Voting days shall be the <u>Thursday and Friday Tuesday and Wednesday</u> of the given week of the semester.
- 11. **Member of a Campaign** Any SGA Member who publicly or privately works with a candidate.
- 12. Ninth (9th) Academic Week The Academic Week in which the Information on Candidates Booklet shall be published in the given week of the Fall and Spring Semesters.
- 13. **Publicly Posted** Conspicuously posted in the SGA Office & on the SGA website under the Election's tab.
- 14. Seventh (7th) Eighth (8th) Academic Week The Academic Week in which Mandatory Candidates Meetings shall be held.
- 15. **SGA Presidential Race** The SGA Presidential race includes candidates for SGA President and SGA Vice President running together as one (1) ticket.
- 16. **Signatures** Signatures required for Presidential and CAC Chair petitions may be collected physically or online. Physical signatures must include the following information: OU ID number, name, and signature. Digital signatures must be authenticated through an online platform that can be integrated with OU's single signon (SSO). The process for digital signatures must be jointly approved by the Election Commissioner and the Office of Student Affairs.
- 17. Sixth (6th) Seventh (7th) Academic Week The Academic Week in which filing for Candidates wishing to run in the upcoming election closes. Filing shall close at the end of the last Class Day of the given week.
- 18. **Unsolicited** Any unrequested electronic message sent through an OU-maintained service (eg. OU email, Canvas, etc.), for the purpose of explicitly requesting a vote or support.
- 2. **Applicability of Election Rules**. The policies, regulations, and stipulations in this Title shall be applicable only to candidates for positions that are named in sections four (4) and five (5) hereinafter. All other campus organizations and bodies wishing to conduct an election may individually establish procedures for that election.
- 3. **Purpose of Election Rules**. The provisions governing elections are intended to provide for the fairness, equitability, and efficiency of all SGA elections with respect to both candidates and voters. In the absence of established guidelines, rulings concerning elections should be made with this principle in mind.

- 4. **Spring General Election**. The following shall be elected in the Spring General Election:
  - 1. the Campus Activities Council (CAC) Chair,
  - 2. Undergraduate Student Congress Representative Seats, and
  - 3. the Student Bar Association (SBA) President.
- 5. **Fall General Election**. The following shall be elected in the Fall General Election:
  - 1. The SGA President and Vice-President;
  - 2. Undergraduate Student Congress Representative Seats.
- 6. **Vacancies.** The SGA President shall be notified in writing of any vacancy that occurs in the positions listed in sections 4 and 5, above. If the SGA President resigns, they shall notify the Chairs of both Houses of the Legislative Branch. The number of seats available for election shall not change after the filing period begins.
  - 1. **Election to Fill Vacancy**. Should a Congressional Seat become vacant after filing has opened, so long as a vacancy in that district was already made public and was included on the filing form during filing for candidates to apply, that new vacant seat may be filled at the time of election using the point tabulation system. If the district was never included initially on the filing form, then that seat shall not be filled during the active general election.
  - 2. **Appointment to Fill Vacancy**. For each position listed in sections 4 and 5 above, other than SGA President, Vice President, and CAC Chair, the organization of which the appointment is needed to be made, that organization shall determine their own appointment qualifications. Those listed in the aforementioned sentence, shall be up for election in the next possible general election.
- 7. **Uncontested Elections**. All positions for which one has filed for election, they must be placed on the ballot in the respective district, even if the position is uncontested. In an uncontested election, the candidate shall win if they receive more votes than the "prefer not to vote" option.
- Section 4: AMENDATORY: The University of Oklahoma Student Government Association Code Annotated Title VI, Chapter 2 is amended as follows. For the purposes of this bill, all items removed shall be denoted with a strikethrough. All items added shall be denoted with an underline.

#### **Chapter VI-2 Election Rules**

- 1. **Electorate.** The electorate of the SGA Presidential and the CAC Chair races shall consist of all members of the SGA. Subject to any applicable provisions of the SGA Constitution, the Legislative Branch shall establish the electorate for all other races in General and/or Special Elections. In the absence of any guidance from the Legislative Branch, the Election Commission may adopt any rules established by the affected organization to determine the electorate for a specific race.
- 2. **Election Dates**. The sections below shall be the dates of the general elections, unless the Legislative Branch changes the date by an Act of the Legislative Branch at least three (3) weeks before the week of the date proposed by the legislation. The Election Commissioner shall have the power to waive this three (3) week requirement if they deem that exceptional circumstances warrant a waiver. Any special election, referendum, or initiatives shall be passed by an Act of the Legislative Branch at least three (3) weeks before the week of the date proposed by the legislation. This requirement cannot be waived.
  - 1. **Fall General Election**. The Fall General Election shall be held the <u>Thursday and Friday Tuesday and Wednesday</u> of the <u>eleventh (11th)</u> tenth (10th) academic week of the fall semester. Voting shall open at 8am on <u>Thursday Tuesday</u> and shall close at 8pm on <u>Friday Wednesday</u>.
  - 2. **Spring General Election**. The Spring General Election shall be held the <u>Thursday</u> Tuesday and <u>Friday Wednesday</u> of the eleventh (11th) tenth (10th) Academic Week of

the spring semester. Voting shall open at 8am on <u>Thursday Tuesday</u> and shall close at 8pm on <u>Friday Wednesday</u>.

- 3. **Deadline Requirements**. Any deadline within this Title, except those noted, may be implicitly suspended by the Election Commissioner with the advice and consent of the Election Commission.
- 4. **Election Funding**. The SGA Budgetary Committee shall allocate sufficient funds in each Administrative Appropriations Act to conduct two General Elections, two (2) run-off elections, and at least one (1) special election, including the compensation of all eligible Election Commission members for each election and sufficient publicity for filing and voting.
- 5. **Polling.** If an SGA member cannot vote through the online voting software implemented by the Elections Commission, they shall request a ballot from the Election Commission in person in the SGA Office or over the OU-maintained email service. In doing so, the SGA member shall provide their OU ID as sufficient identification. The ballot may be requested any time after the publishing of the Information on Candidates booklet and shall be sent when the online polls open. The alternative ballot must be accepted during the online polling days and normal business hours of the Student Life office. The Election Commission shall ensure that any person that used an alternative ballot cannot and did not vote more than once (1) in any election.
- 6. **Voter's Rights**. The following rights should not be infringed upon:
  - 1. The right of the student to vote by secret ballot shall not be infringed. The right of the student to arrive at a voting decision free from undue influence shall not be infringed.
  - 2. No person(s), group(s), or organization(s), regardless of their affiliation, shall require any student(s) to vote, or shall require any student(s) to vote either for or against any proposal, candidate, or candidates in any SGA sanctioned election.
  - 3. Any SGA member has the right to request, in writing, a ruling of the Election Commissioner at any time during the campaign period. The Election Commissioner shall make a written ruling on any such petition within twenty-four (24) hours of its submission.

## 7. Procedure for Run-off.

- 1. The Presidential, SBA, and CAC races shall be popularly elected by a simple majority vote (fifty percent (50%) plus one (1) vote) of the ballots cast for that purpose. In any of the aforementioned races, should no candidate receive a simple majority vote (fifty percent (50%) plus one (1) vote), the top two candidates shall be placed on the ballot for a runoff election to occur on the <u>Thursday Tuesday</u> immediately following the original election date. The top vote-recipient of the runoff election shall be declared the winner.
- 2. The Congressional Representative Seats shall be popularly elected. If in any of the Congressional Representative Seat races, any of the candidates with the least amount of winning popular votes shall tie for an open seat, the candidates shall be placed on the ballot for a run-off election to occur on the <u>Thursday Tuesday</u> immediately following the original election date. The top-vote recipient of the run-off election shall be declared the winner.

# **Chapter IV-6 The SGA Elections Commission**

1. **Power.** The Election Commission shall be responsible for overseeing and enforcing all provisions of Title VI of the Code Annotated and ensuring fair elections.

- 2. **Composition.** The Election Commission shall consist of the Election Commissioner, the Election Staff, and a non-voting ex-officio officer of the Congressional Administration Committee of Congress. No member of the Election Commission shall commit election fraud; evidence of fraud shall be presented to the General Council, as provided for in Title VI. Any member of the Election Staff may be removed by recommendation from the SGA President or Election Commissioner with the advice and consent of the Legislative Branch. No member of the Election Commission shall be a candidate or a member of a team campaigning in any election for which they are appointed to work. The Election Commissioner and Staff shall be SGA members and serve from the beginning of the fall semester to the end of the spring semester of a given academic year.
  - 1. **Election Commissioner**. The Election Commissioner shall serve as the chairperson of the Election Commission. They shall only vote in the event of a tie between voting members of the Election Commission Staff. The Election Commissioner shall be appointed by the SGA President with the advice and consent of the Legislative Branch. The appointee must be submitted to the Legislative Branch for advice and consent after the Spring election.
    - 1. **Vacancy.** If the position of Election Commissioner is not filled in accordance with the legislative advising and consenting process, the General Council shall fulfill all duties of the Election Commissioner until one is officially appointed.
    - 2. **Appointing the Election Commission Staff**. The Election Commissioner shall appoint the Election Commission Staff with the advice and consent of the Legislative Branch.
  - 2. **Election Commission**. The Election Commission shall consist of a maximum of seven (7) five (5) SGA members. The membership of the Election Commission shall be posted in a public place. The Election Commission shall be responsible for conducting the election and enforcing the election rules as established by this Title.
  - 3. Non-Voting Ex-Officio Officer of the Congressional Administration Committee. A member of the Congressional Administration Committee chosen by the Chair of the committee shall oversee the Election Commission. They shall have no voting power.
- 3. **Quorum.** A majority of the Election Commission voting members shall constitute a Quorum to conduct business.

This act shall become effective when passed in accordance with the SGA Constitution.
