CONGRESSIONAL BILL AB-109-07 SENATE BILL NO. GS23-30

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Primary Funding for the 2023-2024 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Primary Funding Act of 2023 for

Governmental Organizations"

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of

Oklahoma Student Government Association to the organizations mentioned within.

Section 3: APPROPRIATION. The following amounts are hereby allocated to
