Annual Business Meeting Minutes ~ November 17, 2012 ~ Disney, Orlando, FL

- I. Welcome: Claude Miller welcomed and thanked everyone, then called the meeting to order at 11:02 AM.
- II. Chair Report (Miller & Chock)
 - a. Legislative Assembly
 - i. Dissolution of legislative assembly fiduciary responsibilities of legislative assembly discussed as reason to dissolve legislative assembly. Proposal sought to create 15-18 member board of governors similar to other associations to have fiduciary responsibility. A separate 35 membership committee elected at-large would be created to determine NCA's stance on policy issues. A member would sit in on board of governors meeting without an opportunity to overrule the board of governors decisions. Much distrust of the proposal was expressed in the legislative assembly. The proposal was initially moved to be sent for general approval but was in effect withdrawn with the opportunity to introduce it again. Impression of division on the proposal was requested. A revision of the by-laws would have to be required for the proposal to be passed. Members on the at-large committee would need to campaign to be elected. The division raised questions about how the division would be represented and what the reasons were for such a proposal.
 - 1. Members requested more information about the proposal. Torsten Reimer found good reason for examining structure and functioning of legislative assembly but not clear about what the proposal does.
 - 2. Ed Fink requested more information on how the proposal (and all future proposals) would operate.
 - 3. Graham Body agreed in principle on changing the structure unwilling to vote on any action.
 - 4. A copy of the proposal was distributed in September and was requested to be made available to the division.
 - 5. Mark Hamilton suggested new proposals be put forth to consider the problem.
 - ii. Further discussion of being a non-profit organization, NCA should operate like a non-profit organization. Some discussion occurred on how to spend the surplus of money. Dues will not be raised, but they will not be lowered.
 - iii. High school education in communication approved to allow for backing of high school teachers backing to teach communication courses in other organizations.
 - iv. Approval of importance of courses in general education.
 - v. Education policy in ESL was archived in case problem arises in future.
 - vi. Amended statement on diversity and affirmative action
 - vii. Approved language on domestic partner support for job ads in a dropdown menu for job postings on NCA job site. New job postings will be required to indicate the university's position on domestic partner support.
 - viii 8 million dollars in assets

- ix. Concerns on Disney for venue. Primary concerns for 2012 venue were raised including: hotel room rates, food cost, disdain for Disney. These concerns were not evaluated when choosing venue.
