

## Summer Financial Aid Information

### Summer Aid Program Availability:

- **Pell Grant** – if you were eligible for Pell during the fall and spring, you may be eligible to receive up to a full-time award during the Summer. If you were enrolled full-time fall and spring, you will need to enroll in at least 6 hours during the summer to qualify for a Summer Pell Grant.
- **TEACH** - if you were enrolled full-time fall and spring, you have received your annual limit.
- **Direct Subsidized and Unsubsidized Loans** - we will pre-screen your OU award amounts for 22/23 to assist in determining if you have already met annual loan limits. For more information, visit <https://studentaid.gov/understand-aid/types/loans>.
- **Oklahoma's Promise** - students who meet all the conditions below should be eligible for Oklahoma's Promise funding for the Summer term.
  - received funding during the 22/23 school year
  - have not graduated
  - within the 5 year program limit
  - have maintained SAP
- **PLUS loans, GradPLUS loans, Private Loans** - require an additional loan application for summer. See below for details.
- **Federal Workstudy, Perkins and SEOG** - funds will not be available for Summer 2023.

### Summer Enrollment Requirements for Federal Aid:

- Undergraduates - 6 credit hours
- Graduates/Law - 5 credit hours
- Oklahoma's Promise and some Private loans allow less than 1/2 time enrollment.
- Students may be eligible for a Pell grant at less than 1/2 time enrollment, if the full annual limit was not used during the Fall and Spring.
- Enrollment will be monitored. Aid amounts as well as disbursement dates will be adjusted and/or cancelled accordingly.

### Summer Financial Aid Checklist:

1. File a [22-23 FAFSA](#). If you received Federal Aid for 22/23, you already have a FAFSA on file and it is not necessary to file another.
2. Enroll at least half-time in Summer 2023.
3. Review Eligibility Requirements on the Financial Aid Tab in [ONE](#) and complete any Missing Documents.
4. [PLUS loans](#), [GRADPLUS loans](#), [Private loans](#) - If desired, complete steps 1 and 2 along with the appropriate loan application.
5. [Study Abroad](#) - Students participating in a Summer Study Abroad program must complete Steps 1, 2 and 3, if applicable. (April 1 priority deadline)

## Important Dates and Deadlines:

- April 1, 2023 - Summer Federal Financial Aid Priority Deadline
  - All required documents must be submitted by this date.
  - Students enrolling after this date may not be processed prior to the start of classes
- May 15, 2023 – Short Term Loan applications available
- May 22, 2023 – Disbursement of funds begins for students enrolled in May courses
  - For students not enrolled in May courses, disbursement will occur approximately 10 days prior to the first day of the student’s first course.
- June 25, 2023 - Tuition Due Date

## Summer Study Abroad

### Law Oxford

- Complete all applicable steps listed in above Checklist section.
- Must enroll in a minimum of five (5) credit hours for federal and most private loans.
- Disbursement for Law Oxford will be June 22, 2023 as long as funds have been received at OU.

### OU Education Abroad Approved Programs and OU College Led Programs

- Complete all applicable steps listed in above Checklist section.
- Must be enrolled in 6 hours as an undergrad or 5 hours as a graduate.
- Disbursement will be 10 days prior to your class start date as long as funds have been received at OU.

### Summer SAP (Satisfactory Academic Progress)

- Academic Progress is reviewed for all students after the spring semester ends.
- If you do not pass SAP for Fall 2022/Spring 2023 your Summer Aid will be cancelled.
- If you are on Financial Aid Probation for Spring 2023 your Summer Aid may be delayed.
- If your summer aid is cancelled you may appeal. Appeal deadline is June 16, 2023.
- Students enrolled in courses that begin in May could have their aid delayed until Spring grades have been posted and SAP has been reviewed.
