Please note the following opportunity to arrange for exhibition of your book(s) at the Memphis Convention.

Directions for Using Publisher Contact Form

The Scholar's Choice, a combined book exhibit company that specializes in marketing academic and scholarly books, will be providing a book exhibit at our upcoming SCMLA meeting in Memphis, November 1-3, 2007. They have the ability to include your book(s) if sent to them by your publisher(s). However, you must make the request to your publisher. (While there is no cost to you, publishers do have to pay a fee for this service and meet certain requirements for order fulfillment.)

We have provided the form on the reverse to assist you in making the request(s) to your publisher(s). We ask that you use the following procedures:

1. Use a separate copy of this form (form on reverse; photocopy as needed) for each book you would like to have exhibited. Fill in all the appropriate information, including the name and address of each publisher. The Scholar's Choice has asked that members request only books that are appropriate, albeit in the broadest sense, to the topics of the conference. They have also asked us to be mindful of publication dates. Publishers may not be able to fill orders for older or out-of-stock books.
2. Send one copy of your request directly to your publisher. Send another to us at SCMLA, University of Oklahoma, 104 Fourth Street, Baker, B47, Norman, OK 73019-6410. It is suggested that you do this as early as possible, but no later than **September 14**. Late requests may not be honored either by the publisher or by The Scholar's Choice due to limited exhibit space.
3. Making a request to your publisher does not guarantee that your book will be exhibited. You should contact Debby Pitts at The Scholar's Choice (contact information on reverse) before September 14 to determine whether or not your publisher has reserved your book. If not, you will need to follow up with the publisher directly.
4. Although The Scholar's Choice works primarily with academic and scholarly presses, we have been assured of their willingness to exhibit textbooks, fiction, and/or poetry from any press that can meet their guidelines and fees.
